**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING KEY WEST TRACK & FIELD CLUB, INC. CONDUCT THE ANNUAL POLE VAULT COMPETITION ON SATURDAY, JANUARY 9, 2021, FROM 8:00 A.M. TO 8:00 P.M. (SETTING UP ON THURSDAY, JANUARY 7 , 2021 AND PRACTICE ON FRIDAY, JANUARY 8, 2021 AT THE KEY WEST TRUMAN WATERFRONT GREEN FIELDS NEXT TO SPLASH PAD ; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOL BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Key West Track and Field Club, Inc. request permission to conduct the annual Pole Vault Competition on Saturday, January 9, 2021 from 8:00 am to 8:00 pm ( Set up on Thursday, January 7, 2021 and Practice on Friday, January 8, 2021 from 8:00 a.m. to 8:00 p.m.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That in Resolution 19-174, the City Commission directed the City Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law”

**SECTION 2.** “That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use or distribution of single-use polystyrene/plastic items, including but not limited to single-use polystyrene/plastic straws, bags, plastic

utensils and “to go” packages for food or products sold on any property leased from the City”

**SECTION 3.** That the Key West Track & Field Club, Inc. is hereby granted permission to conduct the annual Key West Track & Field Club, Inc. on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

**SECTION 4.** That Pursuant to Section 18-86 of the Key West Code of Ordinances, the Key West Track & Field Club, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

**SECTION 5.** That Key West Track & Field Club, Inc. must post the required notice regarding prohibition of purchase and sale of alcohol beverages to persons under 21 years of age.

**SECTION 6.** That Key West Track & Field Club, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 7.** That the applicant acknowledges this authorization may be revoked by this Commission, or the City Manager, due to exigent circumstances such as the resurgence of COVID-19 in the Community.

**SECTION 8.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
