Attached is some information we have received while working with the distributer for AAL for the fixture here at Key West Bight. As you know from the Lighting Task Force meeting that we are under the gun here. I also know that Anthony and MBI-K2M have worked with the LTF to get this product approved before my direct involvement. We had the manufacturer reply to the data sheet for light specifications that was sent to me from Dale. The distributer from AAL was able to bring over a sample one day to show us the quality of the fixture and we were very impressed! Enid from HARC, Marilyn, and myself got to see its build and lighting characteristics. The manufacturer agreed to take out the "corrosion environment" language within the warranty as we requested because of the location of the install. The fixture has a 5 year warranty. It is aluminum that will be anodized before being powder coated which will give it excellent corrosion resistance. Also below are a list of projects within the last year or so with this same LED set-up. The pole for the light fixture is a composite over fiberglass shell that will be rated to 150 mph winds as will the arm for the fixture. The pole has a 10 year warranty and is scratch resistant as the color goes all the way through. Each flat glass plate that protects the LED fixture has three screws with knobs for tool-less maintenance and is sealed by a large memory retentive gasket (very solid design). All lights will have potentiometers at the top so that we can change the power output of each light. This is very important to us as we have lights that are in areas as large as plaza/parking lots and lights that will be on 5 ft. wide docks next to restaurants. We feel very confident in the ground work done by Anthony and the information and sample we received from AAL. We have been all systems go since we met but I would like to offer you this information to let you know that we have worked diligently to make sure this purchase is one that the City of Key West will be proud of. If you have any more questions please do not hesitate to contact me.
