A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA (CITY), AUTHORIZING PURSUANT TO SECTION 2-797(3) THE PURCHASE OF ONE NEW CLAW TRUCK AND RELATED SUPPLIES AND EQUIPMENT FROM PETERSEN INDUSTRIES, INC. IN AN AMOUNT NOT TO EXCEED \$207,152.54 THROUGH THE SOURCEWELL COOPERATIVE PURCHASING CONTRACT #040621-PII (SOURCEWELL), CITY OF KEY WEST MEMBER NUMBER 58115; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to government contract; and

WHEREAS, City staff recommends procurement of a new claw truck and related supplies and equipment through the Sourcewell Cooperative Purchasing Contract, #040621-PII; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a new Claw Truck and related supplies and equipment, in an amount not to exceed \$207,152.54, from Petersen Industries, Inc. is hereby approved, through Sourcewell competitive bid contract #040621-PII, City

Member Number 58115, pursuant to Section 2-797(3) of the Code of Ordinances.

Section 2: That funds for this purchase are budgeted in FY 25 in General Fund/Parks and Recreation/Machinery and Equipment Account #001-7201-572-6400. Any related budget adjustments and transfers are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents associated with this purchase, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage, adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
