On The Sonny Side

THERE IS A STORY TO BE TOLD IN THE ARCHITECTURE OF KEY WEST. The Conchs are an insular people that evolved a unique architectural fabric for this island. They were influenced by the shipwrights from New England who brought their boat building craft to constructing homes here, and there was the Cuban influence with their Spanish baroque and cigar factories. The national government and the military brought masons from Baltimore to construct forts and federal buildings, and, the Bahamians brought their own interpretations of the architecture of the Carolinas that needed downsizing to fit their new lives on these Islands.

And, if you look closely you can see the restoration of English Tudor in St. Paul's Church on Duval Street. And then there is the Gato Cigar Factory on Simonton Street and the Truman School on Truman Avenue and of course the Custom House and warehouses at Mallory Square. These structures and the hundreds of restored homes are the successes that the restoration minded people have saved for posterity. And of course there are many partial successes like East and West Martellos, Fort Jefferson and Fort Taylor

and there are, waiting in the wings, such important old structures as the Old Cigar Factory on Staples Avenue and the Harris School on Southard Street.

But then there are the many failures. These are the ones we've allowed to disappear from the island's architectural fabric; with probably the most inexcusable and deliberate mistake of all; the demolition of the Convent of Mary Immaculate. This edifice was deemed to be one of the most valuable structures to be saved in the United States, according to the American Institute of Architects. This venerable classic was not only the most imposing structure on the Island, it was also the repository of much of the history and lore of what this Island of Key West is.

We won some and we lost some, but, at least, there were people here on this Island that preserved enough of the story. So that we need only look up at that imposing old lighthouse on Whitehead Street and just only imagine that it sparked the imagination of that storyteller that lived across the street, in the Hemingway House.

Dear HARC Commissioners:

We are asking you to KEEP OLD TOWN OLD! There is new construction going on in Old Town that does not conform to Old Town architecture (2 Oceans Inn, 616 Eaton Residence and two others). We're not sure why these designs were approved and permits issued and they're too far along to stop construction now, but please do not approve any future building permits for this kind of architecture. The character of Old Town is what makes Key West the unique town that it is. The millionaires and billionaires seem to want to introduce all this new, modern architecture to this area but it does not belong here. We're not against their building; it just that the style needs to blend with the style of Old Town. Take these designs to Stock Island or any of the other Florida Keys, but not Old Town Key West.

Please keep Old Town "OLD" and stop anymore of these modern design schemes from being approved. We support strong guidelines to protect the character of Old Town.

We are residents of Key West who are subject to HARC guidelines for our own home, and we support efforts to maintain the unique character of Key West. It is tragic to see that fall to development pressures that are out of sync with Key West's uniqueness.

Dear HARC Commissioners,

We completely restored a simple 1892 Conch home which we purchased from the original owners in 2007. Though familiar with Monroe County building codes, we necessarily hired a known architect to assist us with Key West's HARC and city building processes. We spent over \$13,000 and waded through a 7-month period of innumerable meetings, building department and FEMA regulations, 3 levels of historical approvals, and trip after trip to the courthouse with notarized documents. We spent a considerable amount and took 5 years to do everything "by the book" to preserve the nature of our home. Now we walk around Old Town and see "reconstruction" and "remodeling" projects that we would not even consider pursuing because we knew they would not meet HARC specifications. We were unaware that HARC had changed many of its guidelines, but the appearance of Old Key West began to noticeably change about 2 years ago. In particular, we see properties being "improved" in ways prohibited to us and unbecoming one of the nation's densest historical districts. Although we consider the procedures we had to endure as unreasonable and unnecessarily

time-consuming, we also respect the intent to maintain the historical significance of our town. What now has changed besides charging many more and much higher fees? Did the hearing committees waive requirements, were the building inspectors on vacation, or do we just not care anymore?
