A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE (1) 2025 FORD F-550 BUCKET TRUCK WITH RELATED ACCESSORIES IN A TOTAL AMOUNT NOT TO EXCEED \$219,202.76 FROM DUVAL FORD LLC, THROUGH PIGGYBACKING ON THE BRADFORD COUNTY SHERIFFS CONTRACT BCSO 22-27-1.0, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES, FOR USE BY THE FACILITIES MAINTENANCE DEPARTMENT; AUTHORIZING NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City staff recommends procurement of a new bucket truck and related supplies and equipment through the Bradford County Sheriff's Contract pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of One (1) 2025 Ford F550 Bucket Truck and related accessories, as described in the attached proposal of Duval Ford LLC, pursuant to section 2-797(3) of the Code of Ordinances, under the Bradford County Sheriff's Contract BCSO 22-27-1.0, in an amount not to exceed \$219,202.76, is hereby authorized for use by the Facilities Maintenance Department.

Section 2: That funds for the purchase of the Bucket Truck are budgeted in General Fund/Facilities Maintenance/Machinery & Equipment 001-1909-519-6400 in the amount of \$200,000.00. Funds in the amount of up to \$19,202.78 will be transferred from General Fund/Parks and Recreation/Machinery and Equipment account 001-7201-72-6400 to cover the balance of the purchase.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.
