A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING BAUER RESTAURANT, DBA KEY WEST SONGWRITERS FESTIVAL TO CONDUCT A SONGWRITERS FESTIVAL ON SATURDAY, MAY 10, 2014 DURING THE HOURS OF 7:00 P.M. TO 10:00 P.M. (SET UP 12:00 NOON) AUTHORIZING THE CLOSURE OF THE 200 BLOCK OF DUVAL STREET INCLUDING GREENE STREET FROM 2:00 P.M. TO 10:00 P.M; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 5:00 P.M. TO 11:00 P.M; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Bauer Restaurant, DBA Key West Songwriters Festival has applied to the City for a Special Event Permit for the Key West Songwriters Festival” on Saturday, May 10, 2014; and

WHEREAS, this event shall take place on the 200 block of Duval Street between the hours of 7:00 p.m. till 10:00 p.m; and

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida:

SECTION 1. That the Bauer Restaurant, DBA Key West Songwriters Festival is hereby granted permission to conduct the Songwriters Festival on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and that 25 % of gross revenue or \$1,000.00, whichever is more, shall be donated to Share Military Initiative.

SECTION 2. That Bauer Restaurant, dba Key West Songwriters Festival. is hereby granted permission for the closure of the 200 block of Duval Street on the date and during the hours stated above.

SECTION 3. That the Bauer Restaurant, dba Key West Songwriters Festival. is granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That the Bauer Restaurant, dba Key West Songwriters Festival will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side;

SECTION 5. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
