

RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING MZF MILE ZERO FIGHTS, LLC TO CONDUCT AN MMA, MUAY THAI AND BOXINGFIGHTS ON SATURDAY, AUGUST 17, 2019 FROM 4:00 P.M. TO MIDNIGHT AT THE TRUMAN WATERFRONT AMPHITHEATRE (ACCESS DAY PRIOR AND AFTER EVENT); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, MZF Mile Zero Fights, LLC wishes to conduct a boxing event at the Truman Waterfront Amphitheatre between the hours of 4:00 a.m. to Midnight on Saturday, August 17, 2019; and

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law.”

SECTION 2. That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/lessee/licensee/contractor therefore commits to refrain from the use of distribution of single-use polystyrene/plastic items, including but not limited to single-use polystyrene/plastic straws, bags, plastic

utensils and “to go” packages for food or products sold on any property leased from the City.”

SECTION 3. That MZF Mile Zero Fights, LLC. is hereby granted permission to conduct a boxing event on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, MZF Mile Zero Fights, LLC is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

SECTION 5. That the MZF Mile Zero Fights, LLC must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

SECTION 6. That MZF Mile Zero Fights, LLC will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash container will be used and that they will be placed side by side.

SECTION 7. MZF Mile Zero Fights, LLC will be responsible for the rental fee of One Thousand (1,000.00) plus tax. In addition, MZF Mile Zero Fights, LLC will be required to pay the Police, Fire and Community Services.

SECTION 8. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
