-- Kalena Marie Schoen Arrest Narrative:

On September 17, 2022, at approximately 0116 hours, Ofc. Hernandez and I (Ofc. Adorno) responded to 224 Duval St (The Bull and Whistle) reference an intoxicated female refusing to leave the establishment.

Upon arrival, we met with the intoxicated female on the second floor of the establishment. The female was later identified as Kalena Schoen. Schoen was advised she had to leave the premises immediately. Schoen was walked to the stairs located on the west side of the premises. Schoen was unable to walk due to her being intoxicated. I was able to assist Schoen by grabbing her right arm and guiding her down the flight of stairs.

As we approached the bottom of the staircase, Schoen started to become aggressive to Ofc. Hernandez after she asked him to pull her hair. Ofc. Hernandez respectfully declined and told Schoen to continue to walk. Schoen attempted to push Ofc. Hernandez with her right arm after stating to him that "he was a fucking dick". Schoen continued to scream at Ofc. Hernandez and called him a "Fuck" multiple times. At the bottom of the staircase, I advised Schoen she was free to go and asked where she was staying at, so we contact a taxi to take her home. After being asked for her address, Schoen grabbed a black satchel she had on her person and with her right arm, threw the satchel at Ofc. Hernandez hitting him in his face. Ofc. Hernandez and I then grabbed both arms of Schoen and placed her against a wall to handcuff her. In our attempts to handcuff Schoen, she began to pull away and push off the wall located directly in front of her. Schoen was advised to stop resisting multiple times. As I placed one handcuff on her right wrist and secured it properly, Schoen once again pushed off the wall, tensed her body and pulled away in attempts to get away. Schoen began to flail her elbows in our direction in attempts to evade us. Ofc. Hernandez and I were able to get a hold of her arms once again and utilized an arm bar takedown to take Schoen to the ground in a controlled manner in order to properly handcuff her. Schoen was then placed in handcuffs, checked for proper fitting, and double locked. While Schoen was on the ground, she used her left leg to kick Ofc. Hernandez two times to the shin area of his right leg. I was able to grab her left leg and hold it down onto the ground. Schoen once again, used her left foot to kick my left leg multiple times. Ofc. Hernandez and I walked Schoen to my patrol vehicle where I conducted an incident to arrest search of her person, placed her in the rear of my patrol vehicle and activated my Coban rear camera. I contacted our watch supervisor, Sgt. Alex Rodriguez to respond to the scene to conduct a response to resistance investigation. Sgt. A. Rodriguez arrived and completed his RRI investigation. Schoen was actively resisting, and due to her level of resistance, we had to meet it with what was reasonable and necessary to prevent further risk of harm to herself as well as others around.

Schoen was transported to Monroe County Detention Center without incident and was handed over to Monroe County Deputies for processing.

Based on the facts and evidence:

Kalena Schoen committed the misdemeanor criminal offense of resisting an officer to his / her person without violence as defined in FSS 843.02 - Schoen obstructed us from our lawful duty during a lawful detainment and subsequent arrest by actively resisting. Schoen tried to defeat our attempts of placing her in handcuffs by tensing up, pulling her arms away from us, and pushing off a nearby wall.

Based on the facts and evidence:

Kalena Schoen actually and intentionally struck Ofc. Hernandez and I against our will contrary to FSS 784.07(b) while we were engaged in our legal and lawful duties as a uniformed law enforcement officer by throwing a black satchel, hitting Ofc. Hernandez and I. Schoen also kicked Ofc. Hernandez and I multiple times as we attempted to

On Saturday September 17, 2022, at about 0115 am hours, Ofc. Sam Adorno and I, (Ofc. L. Hernandez), were dispatched to 224 Duval Street (The Bull and Whistle Bar), in reference to an intoxicated female, refusing to leave and being a nuisance.

Upon arrival, we met with the female, later identified as Kalena Marie Schoen (DOB 06/04/1991) (Arrestee), upstairs on the 2n floor of the establishment near the bar. Schoen was evidently under the influence of alcoholic intoxicant (s) as per her slurred and incoherent speech, strong odor of alcoholic beverages emanating from her breath and person, glassy and droopy eyes, and unsteady walk. Ofc. Adorno and I informed Schoen the establishment wanted her to leave, and we helped and guided her downstairs. As we were assisting Schoen downstairs she would stop and curse at us.

We were trying to get Schoen to tell us where she was staying or where she resides, but she was just focused on arguing and being belligerent. Once downstairs, we tried asking Schoen again to tell us she is staying in Key West and she tried to walk away from us, we told her to stop and calm down and she swung her arms at Ofc. Adorno and I. Due to Schoen current level of intoxication we tried to take control of her to keep her safe. Schoen then she proceeded to toss her purse at me hitting me on my right shoulder. We tried to grab Schoen to detain her, and she tensed up and started to kick us. Schoen kicked me on my right thigh. Schoen kept resisting and we assisted to the ground in a control manner. Once on the ground Schoen began to scream from the top of her lungs. While I was hoding Schoen down, she kept trying to defeat our attempts of keeping her safe, calm and in place by pulling and swaing. Schoen kicked me again on the lower front side of my right leg. I held Schoen's legs down and she eventually calmed down. We placed Schoen in handcuffs, checked them for tightness and double locked them.

We requested Sgt. Alexander Rodriguez respond to the scene to conduct a response to resistance investigation. Sgt. A. Rodriguez arrived on scene and completed the RRI. We placed Schoen in the rear of Ofc. S. Adorno's patrol vehicle. Ofc. S. Adorno transported Schoen to the Monroe County Detention Center.

My BWC (3452) was activated during this incident.
