A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A BLANKET PURCHASE ORDER FOR THE PURCHASE OF MEDICAL SUPPLIES FROM BOUND TREE MEDICAL, LLC PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES, BY PIGGYBACKING ON THE CITY OF BOYNTON BEACH CONTRACT NO 0521-2210-14/JMA, IN A TOTAL AMOUNT NOT TO EXCEED \$80,000.00, FOR THE KEY WEST FIRE DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Key West Fire Department, Emergency Medical Services Division, has expressed an intention to initiate a Request for Proposals for medical and medication supplies for EMS services; and

WHEREAS, until an RFP can be prepared and awarded, the Department recommends the authorization of a blanket purchase order for necessary supplies from Bound Tree Medical, LLC, by piggybacking on a government contract with the City of Boynton Beach, pursuant to Section 2-797(3) of the Code of Ordinances; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an exemption to competitive bid requirements, and a blanket purchase order to authorize the expenditure of funds not

to exceed \$80,000.00 to Bound Tree Medical, LLC for medical and medication supplies for the Key West Fire Department, is hereby approved, pursuant to section 2-797(3) of the Code of Ordinances.

Section 2: That funds for this purchase are budgeted for FY 16-17 in Account #101-2601-526-5200.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
