RESOLUTION 2015-111**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, APPROVING THE MUTUAL AID MEMORANDUM OF UNDERSTANDING FOR FIRE AND EMERGENCY SERVICES ASSISTANCE BETWEEN THE CITY OF MARATHON AND THE CITY OF KEY WEST; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT ON BEHALF OF THE CITY; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City of Marathon and the City of Key West (collectively, referred to as the “Parties”) desire to augment fire and emergency services available in their respective jurisdictions in the event of large fires or unusual emergency incidents; and

WHEREAS, the City deems it to be desirable, sound, practical and beneficial for the Parties to render assistance to one another in accordance with the terms set forth in the attached Memorandum of Understanding (the “MOU”).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MARATHON, FLORIDA, THAT:

Section 1. The above recitals are true and correct and incorporated herein.

Section 2. The City Council hereby approves the MOU for mutual fire and emergency aid attached as Exhibit “A,” together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney. The City Manager is authorized to execute the MOU on behalf of the City.

Section 3. This resolution shall take effect immediately upon its adoption.


