Good afternoon, Commissioner Haskell-

Please be advised that Kendal and I have reviewed the clause in question and have aligned on the interpretation of the following provision:

*"Shall provide a disclosure of all work for other clients that may be affected by work on the proposed contract to avoid a potential conflict of interest."*

Although the term "work" is not explicitly defined within the solicitation, we have interpreted it to encompass any labor, materials, equipment, required to fulfill the obligations of a contractual agreement. Based on this understanding, we do not believe that donations fall within the scope of "work" for the purposes of this disclosure requirement. A donation is generally considered a voluntary transfer of money, goods, or services and does not typically involve labor or services rendered in exchange for compensation or contractual performance. As such, it does not constitute "work" in a contractual or procurement context.

It is also worth noting that only one proposer (RES) submitted the requested conflict of interest disclosure. All other proposers did not provide this documentation or reference, which the selection committee interpreted as an indication that they had no relevant contractual obligations or engagements that would create a potential conflict of interest.

For your convenience, direct responses to your specific questions are provided below.

1. Should this proposal have ever gotten to the scoring stage or should it have been rejected out of hand at the staff level as not meeting the basic requirements of the RFP?

1. Yes, this proposal should have proceeded to the scoring stage. The responsibility for determining whether a proposal is non-responsive or non-conforming rests with the Evaluation Committee, not with staff at the time of submission. This assessment can only be made after the proposals are formally reviewed against the evaluation criteria. Therefore, it was appropriate for the proposal to advance to the scoring stage for full consideration as was done with all other proposals that did not reference this item directly.

Good afternoon, Lucas,

I understand the point you are making about the scoring criteria. However, the RFP clearly states that respondents "shall provide a disclosure of all work for other clients that may be affected by work on the proposed contract to avoid a potential conflict of interest."

A qualified response would include such a disclosure.

Mote has a direct financial interest in the cruise ship operations at Pier B and that financial interest could be jeopardized if it reports water quality violations. This is a clear conflict of interest. Mote did not disclose this conflict, despite the requirement of the RFP that they "shall provide" disclosure of such a conflict. Should this proposal have ever gotten to the scoring stage? Or should it have been rejected out of hand at the staff level as not meeting the basic requirements of the RFP?

### **Mote Marine's Conflicts of Interest re: Monitoring for Water Quality Violations Caused by Cruise Ships at the Pier B Cruiseport**

1. There is only one cruise ship pier in operation in Key West: the Pier B Cruiseport, operated by Pier B Development Corporation.
2. Pier B Development Corporation's lease agreement with the State of Florida requires Pier B to "contribute an annual monetary donation of \$50,000 to the Coral Reef Restoration Initiative through Mote Marine Laboratory, Inc for the full term of the lease."
3. Cruise operations at Pier B are authorized by an Environmental Resource Permit, Consent to Use, and Submerged Lands Lease from the State of Florida; and a permit from the U.S. Army Corps of Engineers. These permits provide for penalties including revocation of Pier B's authority to operate the cruise port if state or federal water quality standards are violated.

The above facts show:

1. Pier B Dev. Corp. is a client of Mote Marine, providing Mote with direct payments of \$50,000 annually for the performance of Mote's "Coral Reef Restoration Initiative." This gives Mote Marine a direct financial interest in the ongoing operation of the Pier B Cruiseport.
2. Pier B's authority to operate its Cruiseport can be revoked if state or federal water quality standards are violated OR if they cease providing \$50,000 annually to Mote Marine.
3. Mote Marine could lose \$50,000 per year if it identifies violations of state or federal water quality standards caused by cruise ships docking at Pier B.

I did not cc commissioners due to Sunshine requirements. But if they can be cc'ed properly, please do so.

Please be advised that while the Conflict of Interest Disclosure was a submission component of the solicitation package, it was not a weighted criterion within the scoring process. The purpose of this document was to support transparency, ethical compliance, and disclosure integrity across all proposers. However, it did not contribute to, nor influence, the numerical scores assigned to each proposal.

As such, the absence of a Conflict of Interest Disclosure from a particular proposer does not impact or alter the validity of the evaluation results. The evaluation matrix—which governs how all proposals are scored—clearly outlines the criteria considered during the evaluation, and the Conflict of Interest Disclosure is not included among the weighted factors. For reference, the evaluation matrix is included below, and the section relevant to this matter has been highlighted for clarity.

Hi Alison,  
80-3 is more specific than that. It requires:

"monitoring of water quality violations **of Sec. 80-2** in the Waterways of the City of Key West"

So yes, violations are defined, and they are defined in Sec 80-2.

80-2 makes it:

"unlawful for any vessel to deposit, place or discharge any pollutant into the waterways of the City of Key West" 80-2(1)

and says:

"Vessels docking at the City of Key West shall at all times be in full compliance with all applicable state, federal and international safety, health and environmental protection statutes, regulations, standards and requirements." 80-2(2)

(In 80-1 "vessel" is defined to mean only cruise ships with more than 500 passengers.)

We know already from the College's data that cruise ships docking at Pier B, on 32 occasions, were NOT in full compliance with state and federal statutes, regulations, and standards pertaining to turbidity.

It is not that the ordinance requires the City to test the harbor, per se. But it is required to test for **pollutants discharged by cruise ships in the waterways of Key West**. Since the only portion of the waterways of Key West in which cruise ships operate is the harbor and a portion of the ship channel, then it makes sense to test those locations before any others.

Dear Mayor Henriquez and City of Key West Commissioners,

Organized in the State of Florida in 1955, Mote Marine Laboratory has eight campuses stretching from Anna Maria Island to Key West. Five Mote campuses are in the Florida Keys where we have had research facilities conducting diverse research and monitoring for over 32 years, and anchored by our International Center for Coral Reef Research and Restoration (IC2R3) on the Mote Summerland Key campus where we have ~35 of our over 50 full-time Keys based staff.

Mote is committed to providing services to our communities in the Florida Keys. Therefore, we appreciated the opportunity to submit a proposal to the City of Key West to serve as its water quality monitoring program provider, in response to RFP 25-004.

We are grateful for the hard work and dedication of the City's water quality monitoring program RFP review and scoring committee. Key conclusions of the review and scoring committee are that:

- 2 of 5 reviewers ranked Mote as #1.
- 2 of 5 reviewers rank RES #1.
- 1 of 5 reviewers ranked Stantec as #1.
- Of these three #1 ranked applicants, Mote was ~20% lower in cost (~\$21,600 lower than RES and ~\$26,300 lower than Stantec).

In addition, and given no statistical difference in final total scores between Mote and RES, we respectfully wish to bring to the City's attention several concerns/irregularities we perceive in the review and scoring outcomes.

- Reviewer M. McCleary gave Mote ZERO points for local preference but also checked that Mote had the local vendor certification, and as a result Mote should have received a positive score in this category (especially given Mote's over 32 years of research and monitoring operations and facilities in the Keys as noted above).
- Reviewer S. Kruger's notes were not included in public packet – if there is a record of these review notes, we would appreciate receiving them.
- Reviewer S. McCoy gave a point (+1) above the allowed range (-5 to 0) to RES for city forms.

- Reviewer A. Higgins' math appears to incorrectly indicate a score of 86 for Mote. Her total score for Mote should be 89 or 92 dependent on whether her score applied the 15 or 18 she wrote for Criteria 3 (Project Approach).

From the information provided to applicants in the City RFP announcement, our understanding of the final selection process is that: 1) the review and scoring committee will submit their tabulated scores and firm/individual ranking to the City Commission for their consideration; 2) the City Commission may accept the ranking recommendations of the committee or may amend rankings; 3) the City Commission may in its discretion waive any informalities and irregularities contained in a proposal or in the manner of its submittal; and 4) the City Commission will make the final selection.

Again, Mote appreciates the opportunity to provide our bid for this important water quality monitoring program, and we remain committed to providing services to our communities in Key West and throughout the Florida Keys.
