



-- Lori Lynn Rheingold Arrest Narrative:

On 04/23/2024 at approximately 0921 hours, I, Officer Leahy responded to 301 White Street (Porter Place) in reference to a female armed with a knife.

Upon arrival, I saw a white female later identified by her Florida driver's license number as Lori Lynn Rheingold (Arrestee) standing in front of Building 3 screaming towards the front door of Apartment 3D. I contacted another white female, identified by her Florida driver's license number as Grisell George (Victim) who is a Housing Supervisor with Key West Housing Authority (KWHA). George was standing in the doorway of Apartment 3D. Georgel told me that Rheingold was the person who had possessed the knife and had the knife pointed at her (George).

I approached Rheingold and told her to place her hands behind her back several times. Rheingold refused to place her hands behind her back, not complying with my lawful command. I approached Rheingold and took hold of her right arm and shoulder area. I directed Rheingold to the grass in a controlled manner. I handcuffed Rheingold pending further investigation. I helped Rheingold to her feet and escorted her to my patrol vehicle.

I observed Rheingold to have the odor of an alcoholic beverage emanating from her breath and person. I observed Rheingold to have glassy bloodshot eyes, slurred speech and she was unsteady on her feet. I suspected Rheingold was under the influence of an alcoholic beverage and intoxicated. I had asked Rheingold if she was drinking this morning. Rheingold said she was drinking in her own home and stated she had two chocolate martinis and a Bud Light.

Officer Standerwick arrived on scene. I turned Rheingold over to Officer Standerwick while I interviewed the victim and witnesses.

I spoke to George who told me she was at Apartment 3D to conduct an inspection as the previous tenant was evicted. George said she heard banging on the front door. George said when she opened the front door, Rheingold was standing in front of the door with a knife raised up in the air. George told me Rheingold said to her, "You evicted little kids how dare you do that." George said Rheingold kept the knife raised as Rheingold yelled at her.(George). George said she never moved forward with the knife just held the knife up in a threatening position. George said she slammed the door closed and advised the other two people she was with. Those two people a black female identified by her Florida driver's license number as Aurora Exum (witness/KWHA manager) and a white male identified by his Florida driver's license number as Antonio Alfonso (witness/KWHA maintenance). George said Alfonso exited the back door of the apartment and was able to disarm Rheingold at the front of the apartment. George said Alfonso brought the knife into the apartment to secure it. I confirmed with George when she saw the knife was she in fear for her safety. George said absoluetly she was she didn't know what Rheingold was going to do.

I spoke to Alfonso who confirmed what George had told me only adding when he confronted Rheingold at the front of the apartment, she dropped the knife to the ground when she saw him (Alfonso).

I spoke to Exum who said she was present inside the apartment. Exum said she looked out the window of the apartment after George had slammed the door. Exum said she saw Rheingold standing at the front door entrance still holding the knife in the air.

I walked back to my patrol vehicle where Officer Standerwick was still present with Rheingold. Officer Standerwick had advised Rheingold of her Miranda Rights. Rheingold waived her rights and agreed to speak to us without a lawyer present. Rheingold said she was concerned about a male she referred to as Darrian Knowles being in the apartment. Rheingold said Knowles had drowned a dog belonging to the previous tenant. Rheingold said the dog was drowned by Knowles on the second floor of the apartment. Rheingold confirmed she grabbed a butcher knife from her residence and proceeded to Apartment 3D because she feared Knowles and saw the front door of the apartment opened earlier. Rheingold said she saw the housing people when the door opened. Rheingold denies telling the housing people she was upset about the kids being evicted. And raising the knife Rheingold said she threw the knife on the ground immediately after she confronted the housing people in the apartment which conflicts with what witness stated of Rheingold still holding the knife until confronted by Alfonso. Rheingold made a spontaneous utterance in my patrol vehicle while enroute to the jail of "Lucky I didn't have a pistol."

The knife was recovered by Officer Stutz who arrived on scene to assist. I photographed the large butcher knife. Officer Stutz placed the knife into the Key West Police Department Property Section as evidence.

Based on the facts and evidence. I believe there is probable cause that on 04/23/2024, Lori Lynn Rheingold did knowingly and intentionally raise a knife and pointed it at Grisell George in a threatening manner violating FSS 784.021 (1)(a) aggravated assault with a deadly weapon without intent to kill.

Based on the facts and evidence. I believe there is probable cause that on 04/23/2024, Lori Lynn Rheingold did knowingly and intentionally not comply with my lawful commands to place her hands behind her back obstructing myself to perform my lawful duties to handcuff her violating FSS 843.02 resisting without violence

I transported Rheingold to the Monroe County Detention Center.

My AXON BWC and in-car cameras were activated.

Due to property IBR errors I cannot submit report. I have submitted and uploaded BWC, in-car camera videos and a photo to Evidence.com

On Tuesday, April 23, 2024, at approximately 0925 hours, Ofc. Leahy, Ofc. Standerwick, Ofc. Perez, and I (Ofc. Stutz) were dispatched to a report of an armed subject at 301 White St. Apartment 3D.

Upon my arrival, Ofc. Leahy and Ofc. Standerwick had already placed the offender, identified as Lori Rheingold, into custody reference aggravated assault with a deadly weapon. I approached Ofc. Leahy who was speaking to the victim outside Apartment 3D. Ofc. Leahy requested I retrieve the knife used in the assault from inside the apartment. Key West Housing Authority Employees conducting an eviction led me into the apartment and directed me to a large kitchen knife that was on a dining table. I secured the knife and exited the apartment.

Upon my exit, the witness speaking to Ofc. Leahy looked at the knife and said, "Yup, that's it." (Referring to the knife)

I returned to the Key West Police Department and entered the knife into the Property and Evidence Section.

I did not speak directly to any of the involved parties in reference to the incident.

My BWC was activated for this incident and entered into evidence.
