A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING INTEGRITY MULTISPORT, INC. TO CONDUCT THE SOUTHERNMOST HALF MARATHON, ON SUNDAY, OCTOBER 12, 2025, FROM 6:00 A.M. TO 10:00 A.M., (SET UP WILL BE AT HIGGS BEACH ON SATURDAY, OCTOBER 11, 2025); THE RACE WILL BE STARTING FROM HIGGS BEACH PARK AND ENDING AT HIGGS BEACH AFTER RUNNING THROUGH THE CITY; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Integrity Multisport, Inc. wishes to conduct the Southernmost Half Marathon on Sunday, October 12, 2025, starting at 6:00 a.m. to 10:00 a.m.; and

WHEREAS, this events course will utilize parts of city streets.

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida.

SECTION 1. That in Resolution 19-174, the City Commission directed the city Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore, commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "to go" packages for food or products sold on any property leased from the City."

SECTION 3. That Integrity Multisport, Inc. is hereby granted permission to conduct the "Southernmost Half Marathon" on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

SECTION 4. That Integrity Multisport, Inc. acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 5. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
