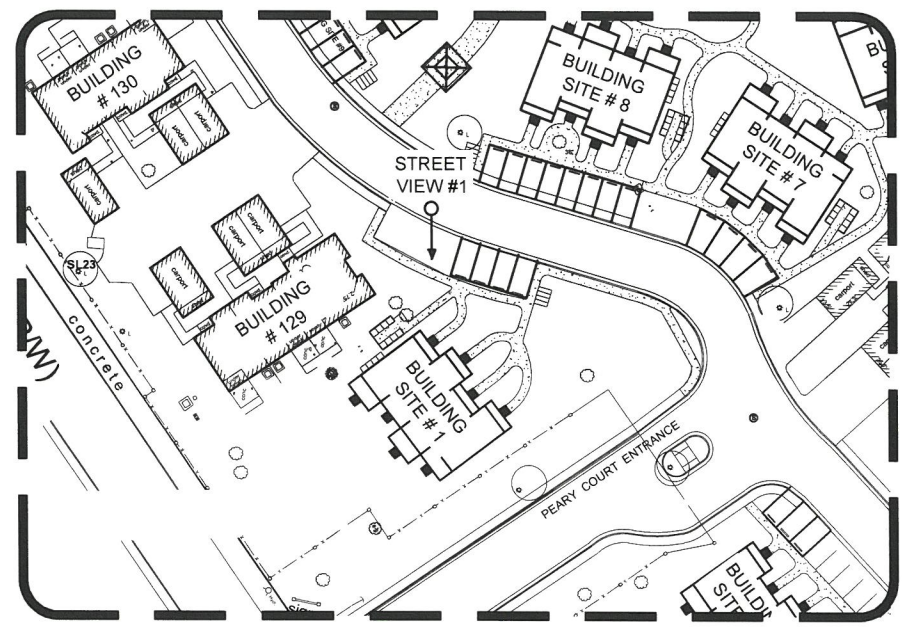

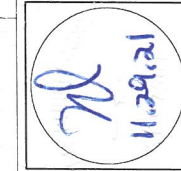


2 SITE MAP SHOWING RENDER LOCATION

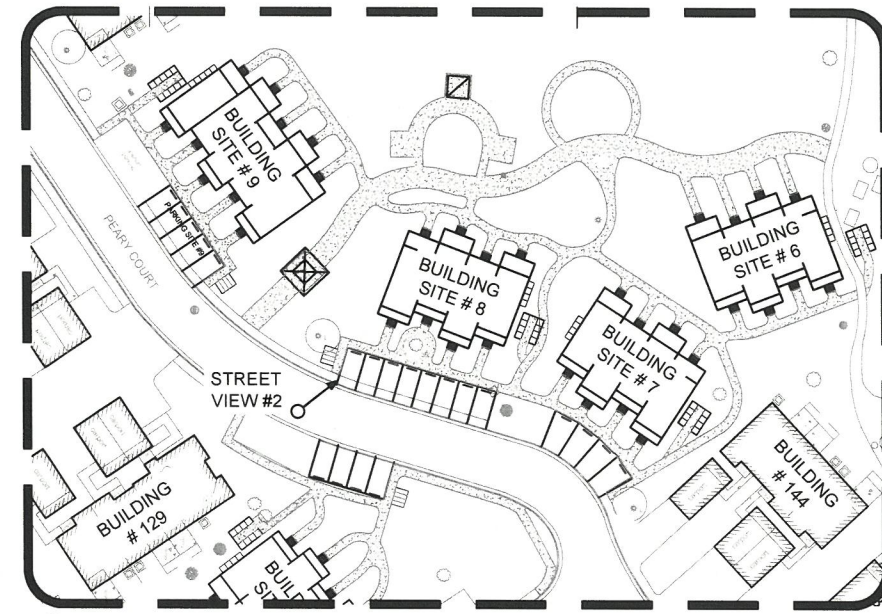

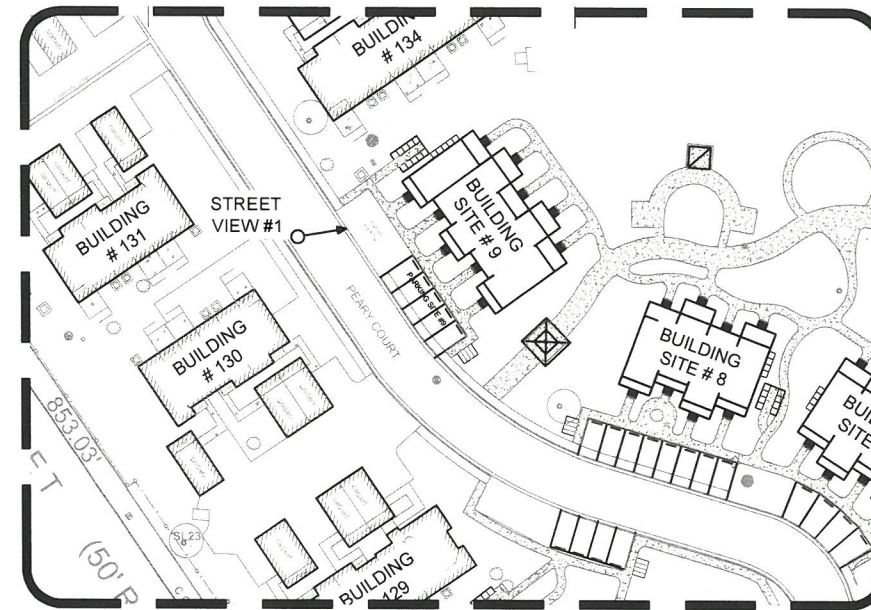

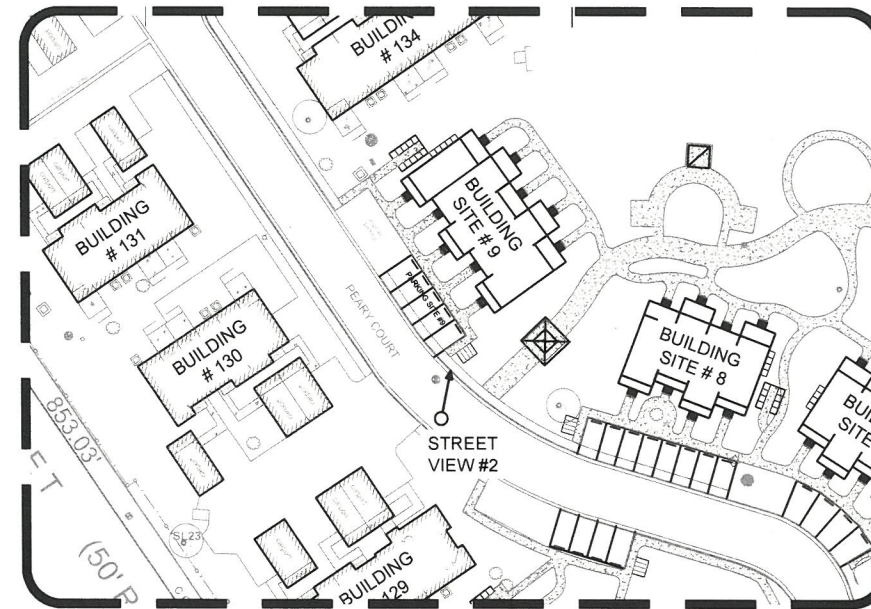
