A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, GRANTING/DENYING THE APPEAL OF ALON CROITORU, BY AFFIRMING/REVERSING THE DETERMINATION OF THE PLANNING BOARD RENDERED IN RESOLUTION 2020-12, DENYING AN APPLICATION FOR OUTDOOR MERCHANDISE DISPLAY AT 501C GREENE STREET (ISLAND CIGAR FACTORY); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, at its meeting of June 2, 2020, the City Commission conducted a quasi-judicial hearing concerning an appeal by the Appellant of a decision rendered by the Planning Board, denying an outdoor merchandise display application at 501-C Green Street by Alon Croitoru(Island Cigar Factory); and

WHEREAS, in accordance with City Code of Ordinances section 90-431, the City Commission considered the record upon which the Planning Board rendered this decision and provided opportunity for presentation by the appellant, and the Planning Department; and

WHEREAS, City Code of Ordinances section 90-427 provides that "...other decisions of the planning board, shall be advisory to the city commission" and section 90-431(4) requires "The concurring

vote of no less than four members of the City Commission... shall be necessary to reverse or modify any order, requirement, decision or determination of the planning board..."; and

WHEREAS, the City Commission found the determination of the Planning Board, **inconsistent/consistent** with the procedural and substantive provisions of Florida Statutes, the adopted Key West comprehensive plan, and land development regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE BY CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the Appeal of the denial for outdoor Merchandise Display set forth in Planning Board Resolution 2020-12 is hereby **granted/denied**, and the decision of the Planning Board is **affirmed/reversed**.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
