A RESOLUTION OF THE CITY COMMISSION OF THE CITY KEY WEST, FLORIDA, APPROVING ALLOCATION OF FUNDING TO THE KEY WEST HOUSING AUTHORITY IN THE AMOUNT OF \$150,333.10 FOR FISCAL YEAR 2022-2023 AND ALL YEARS PRIOR FOR THE OPERATIONAL SUPPORT FOR THE COMMUNITY DEVELOPMENT OFFICE FROM ACCOUNT NUMBER 120-5401-554-3100; AUTHORIZING ANY AMENDMENTS OR ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 20-092 the City Commission approved the renewal of an Administrative Agreement and Management Plan for the Community Development Office between the City of Key West and the Housing Authority of the City of Key West for the period of October 1, 2019 through September 30, 2024; and

WHEREAS, in the Administrative Agreement and Management Plan, the City of Key West agrees to provide sufficient funding to allow the effective management of the Community Development Office; and

WHEREAS, in Resolution 23-023 the City Commission authorized the City Manager to negotiate a transition agreement for the City to assume responsibilities if the Community Development Office from the Key West Housing Authority; and

WHEREAS, the transition of all the operational and financial Page 1 of 3 matters of the Community Development Office began in December 2022 and was complete in August, 2023; and

WHEREAS, as a result of financial reconciliation for Fiscal Year 2022-2023 and all years prior, a funding allocation in the amount of \$150,333.10 is necessary to reimburse the Key West Housing Authority for its role in the operations of the Community Development Office; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: A funding allocation to the Key West Housing Housing Authority for the operational support of the Community Development Office for Fiscal Year 2022-2023 and all years prior, in the amount of \$150,333.10 from Community Development Office account 120-5401-554-3100, is hereby approved. Any budget transfers or adjustments are hereby approved.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
