A RESOLUTION OF THE CITY COMMISSION OF THE KEY WEST, FLORIDA, "AMENDMENT (1ST AMENDMENT) TO AGREEMENT" ID #3231 TO EXTEND THE TERMINATION DATE SEPTEMBER 30, 2026 FOR TOURIST DEVELOPMENT COUNCIL FUNDING OF THE SOUTHERNMOST PLAZA (PUBLIC FACILITIES) CITY AUTHORIZING THE MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY: PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 24-161 the City of Key West accepted a Grant Award from the Tourist Development Council to assist with Phase 2 construction of improvements at the Southernmost Point buoy and the block of Whitehead Street up to United Street (Agreement ID #3231); and

WHEREAS, City staff recommends approving the attached Amendment to Agreement ID #3231, which grants a no-cost time extension for the project and makes the termination date of both Phase 1 and Phase 2 of the Southernmost Plaza grants the same; and NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Amendment (1st Amendment) to Agreement" (ID #3231), to extend the termination date for the Southernmost Plaza Phase 2 (Public Facilities) project to September 30, 2026, is hereby approved.

Section 2: That no cost adjustments are associated with this time extension.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
