A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF SEAMAR DIVERS, INC. IN RESPONSE TO ITB #001-16 IN THE AMOUNT OF \$13,722.90 PER YEAR FOR MOORING FIELD INSPECTIONS (TWO INSPECTIONS AT \$6,861.45 PER YEAR); AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE CONTRACT DOCUMENTS CONTAINED IN ITB #001-16, UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Key West operates a mooring field where there is a need for inspections of up to 149 permitted mooring systems on a regular basis, and/or when severe weather or other marine incidents may affect the integrity of the mooring systems; and

WHEREAS, Seamar Divers, LLC submitted the lowest responsive bid in response to ITB #001-16;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Seamar Divers, Inc. in response to ITB #001-16 for mooring field inspections, is hereby awarded at a price of \$13,722.90 per year (\$6,861.45 per inspection), for a contract term of three years with up to two(2) two-year renewals.

Section 2: That the City Manager is authorized to execute a contract in substantial conformance with the contract documents contained in ITB #001-16, upon advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
