A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER UNDER THE CITY'S GENERAL UTILITIES CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$52,661.12 FOR SOUTH STREET ADA SIDEWALK AND DRAINAGE IMPROVEMENTS; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 15-292, the City Commission approved a three-year General Utilities contract with Charley Toppino & Sons, Inc., in Resolution No. 18-014 the Contract was amended to incorporate certain Federal Contracting provisions, and in Resolution 18-322 the contract was renewed for two years; and

WHEREAS, the construction of the South Beach Pocket Park will raise elevations within the 1400 Block of Duval Street to be equal with the curb grade, and City staff recommends that a raised sidewalk connection across Duval Street adjacent to the new park will improve ADA accessibility, drainage and the overall appearance of the new pedestrian-friendly area; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Task Order under the
City's General Utilities Contract with Charley Toppino &
Sons, Inc. in a total amount not to exceed \$52,661.12, for
South Street ADA Sidewalk and Drainage Improvements is hereby
approved.

Section 2: That this project will be funded from
Account No. 101-7201-573-6300, Project IS72011803. Any
necessary budget adjustments are authorized.

Section 3: That the City Manager is authorized to
execute any necessary documents for this Task Order, upon
consent of the City Attorney.

Section 4: That this Resolution shall go into effect
immediately upon its passage and adoption and authentication
by the signature of the Presiding Officer and the Clerk of
the Commission.
