AUTHORIZING THE CLOSURE OF THE 200 BLOCK OF DUVAL STREET FROM 3:30 P.M. TO 10:30 P.M;GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 6:00 P.M. TO 9:00 P.M;AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

SECTION 2. That the Mel Fisher Maritime Heritage Society, Inc. is hereby granted

permission for the closure of the 200 block of Duval Street on the date and during the hours stated above.

SECTION 3. That the Mel Fisher Maritime Heritage Society Inc. is granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, The Mel Fisher Maritime Heritage Society, Inc is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.
