

RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A.H. OF MONROE COUNTY, INC TO CONDUCT A ROYAL CORONATION BALL FOR THE KING & QUEEN OF FANTASY FEST AT THE KEY WEST TRUMAN WATERFRONT COFFEE BUTLER AMPHITHEATRE ON FRIDAY, OCTOBER 21, 2022, FROM 6:00 P.M. TO 10:00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, A.H. of Monroe County, Inc. wishes to conduct the Royal Coronation Ball at the Truman Waterfront Amphitheatre between the hours of 6:00 p.m. to 10:00 p.m. on Friday, October 21, 2022.

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida.

SECTION 1. That in Resolution 19-174, the City Commission directed the city Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law”

SECTION 2. “That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore, commits to refrain from the use or distribution of single-use polystyrene/plastic items, including but not limited to single-use polystyrene/plastic straws, bags, plastic utensils and “to go” packages for food or products sold on any property leased from the

City”

SECTION 3. A.H. of Monroe County, Inc. is hereby granted permission to conduct the Royal Coronation Ball on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, A.H. of Monroe County, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

SECTION 5. That On Pointe Restaurant Group, LLC DBA La Trattoria Venezia must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age. Proof of compliance with Supplement F, paragraph 3 of the application is required at least ten (10) days in advance.

SECTION 6. A.H. of Monroe County, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash container will be used and that they will be placed side by side.

SECTION 7. A.H. of Monroe County, Inc. will be responsible for the rental fee of five hundred \$(500.00) dollars. In addition, A.H. of Monroe County, Inc. will be required to pay the Police, Fire and Community Services before the event.

SECTION 8. A.H. of Monroe County, Inc acknowledges this authorization may be revoked by the Commission or City Manager, due to exigent circumstances such as the resurgence of COVID-19 in the community.

SECTION 9. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
