A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDING THE BID OF AMERICAN EMPIRE BUILDERS, INC. IN RESPONSE TO ITB #20-006 IN A TOTAL AMOUNT NOT TO EXCEED \$1,640,000.00, FOR KINGFISH PIER REPAIR AND IMPROVEMENTS - HURRICANE IRMA DAMAGE AT CITY GARRISON BIGHT; APPROVING MARINA \mathbf{AT} NECESSARY BUDGET ADJUSTMENTS OR TRANSFERS; AUTHORIZING THE CITY MANAGER TO NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in September 2017, Hurricane Irma caused extensive damage to several piers, including Kingfish Pier at City Marina at Garrison Bight; and

WHEREAS, the pier repair and improvements include an aluminum framed floating dock with ADA compliant gangway connecting to the existing wood dock, new power/water pedestals and sewer hydrants, HDPE piping for water, sewer, fire protection and electrical G-cable; and

WHEREAS, six responses were opened in response to ITB 20-006 on February 19, 2020, and City staff recommends award of bid to the lowest responsive bidder, American Empire Builders, Inc.; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the bid of American Empire Builders,

Inc. is hereby awarded in an amount not to exceed \$1,640,000.00,

as specified in the response to ITB #20-006, the terms and

conditions of which are incorporated herein.

Section 2: That reimbursement funds at 90% of cost are anticipated from FEMA for this expense, due to Hurricane Irma damage, with 5% funding contributed from the State of Florida. Approximately \$82,000.00 (remaining five (5%) percent) has been appropriated in the FY2020 cash carry forward, and any necessary budget adjustments or transfers are authorized (Project HU1701GB09).

Section 3: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney, that are consistent with ITB #20-006 and the approval granted herein.
