A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING KEY WEST COMMUNITY SAILING CENTER TO CONDUCT A "SOUTHERNMOST YOUTH REGATTA" AT THE TRUMAN WATERFRONT QUAY WALL, THE PLAYGROUND SIDE OF THE BOAT RAMP AND THE GRAVEL LOT ON FRIDAY, JANUARY 16, 2026 THROUGH SUNDAY, JANUARY 18, 2026, FROM 8:00 A.M. TO 8:00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Key West Community Sailing Center has applied to the City for a Special Event Permit for a "Southernmost Youth Regatta" at the Key West Truman Waterfront Park Quay Wall, playground side of the boat ramp and the gravel lot on Friday, January 16, 2026, through Sunday, January 18, 2026, from 8:00 a.m. to 8:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST FLORIDA.

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily

recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

SECTION 3. That Key West Community Sailing Center is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the time and place herein described; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that the organization meets the terms and conditions set forth by the City Manager.

SECTION 4. That Key West Community Sailing Center is hereby granted permission for the use of Truman Waterfront Park Quay Wall, the playground side of the boat ramp and the gravel lot.

SECTION 5. That Key West Community Sailing Center will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. That Key West Community Sailing Center acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 7. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the

signatures of the presiding officer and the Clerk of the
Commission.
