This Supplemental Agreement will fund construction of foundations associated with Transit Stop Lighting as part of the greater project to improve bike facilities for bus routes.

This Supplement Agreement will increase construction funds from Supplemental Agreement #1 dated 12/12/2022, by \$228,000.00 which will be split 50% with the City and 50% via Federal funds.
