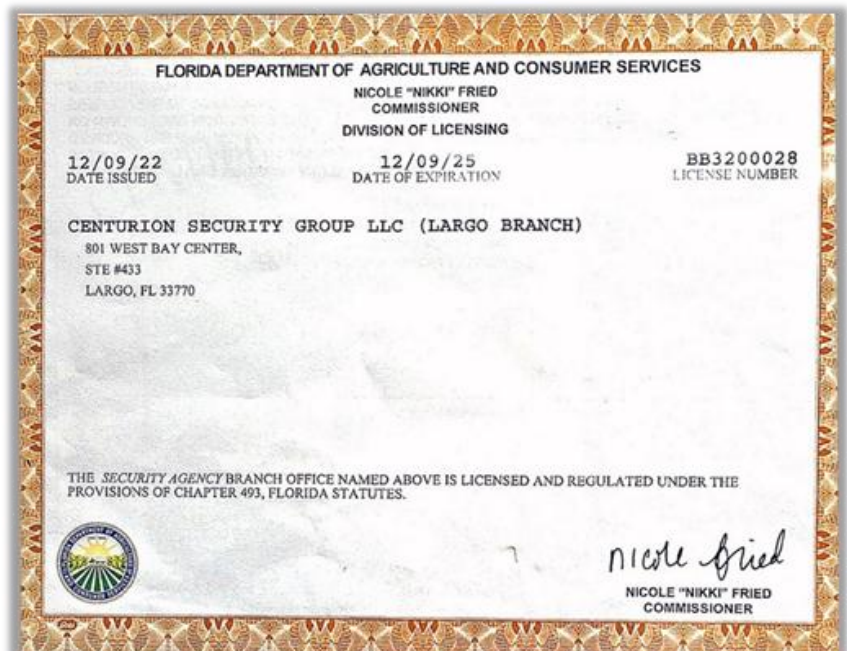

## 4.2 Background checks

Whenever a position becomes available that matches the abilities of an applicant, Centurion Security ensures that the applicant then successfully passes a comprehensive background examination, which may include polygraph and psychological evaluations. This also applies to any agents, representatives, and subcontractors. In addition, if requested, we will re-screen any applicant.

## TAB 5. APPROACH TO SCOPE OF WORK

Centurion Security Group will deliver unarmed private security services to the City of Key West through a structured, scalable, and compliance-based approach. Our model integrates qualified personnel, real-time supervision, and proven coordination practices tailored to the demands of waterfront, high-traffic municipal sites.

### 5.1 Personnel deployment and patrol structure

- **Unarmed officer assignments:** Officers will be assigned to the Key West Bight, Key West Bright Ferry Terminal, and City Marina with shift coverage structured per operational requirements. Schedules will align with post orders and access hours.
- **Mobile roving services:** Roving patrol teams will rotate through designated areas including parking decks and adjoining waterfront zones to support deterrence and incident response. Patrols will be randomized within established time blocks to avoid predictability.
- **Uniform and equipment:** All officer will wear standardized uniforms with visible identification, carry radios or ProxiGuard-compatible smartphones, and log activities per the City's reporting procedures.
- **Vehicles for Roving Posts:**  
Centurion Security will supply all the required vehicles when needed to be used for roving services and assume responsibility for all fuel and vehicle maintenance. Visibly – all vehicles will be identified as "Security" vehicles used in the performance of Security Officer services at the assigned City locations.  
Once active at the site locations we will be able to identify the exact type of vehicles necessary to maintain security surveillance of the area at a minimum expense. Coverage model and operational planning
- **Site-specific staffing:** We recognize the 24/7 operational needs of marine terminals and other city facilities. Centurion will allocate full-time staff and floaters for coverage without interruption, including weekends and holidays.
- **Supervisory oversight:** A designated security supervisor will be available within 35 miles of Key West. This individual will conduct regular inspections, serve as the escalation point for City staff, and oversee all compliance reporting.
- **Transition plan:** Upon award, Centurion will initiate a 15-day transition timeline that includes onboarding, orientation, and alignment with post expectations. We will review prior logs and coordinate with current City personnel for a smooth service handover.







## 5.2 Incident response and communications

- **Real-time communication:** Officers will maintain open channels with dispatch supervisors and local first responders. Emergency incidents will be escalated directly to Key West Police as required, with officer follow-up reports filed within 24 hours.
- **Reporting tools:** Centurion uses incident report templates, daily activity logs, and ProxiGuard-compatible tracking software. The City will receive digital and hard-copy access to logs as specified.

## 5.3 Officer training and role readiness

Each assigned officer will have completed:

- Site-specific orientation before their first shift
- Training on post orders, visitor interaction, and City policies
- Annual CPR, First Aid, de-escalation, and public engagement refresher sessions

This training exceeds the base licensure required under Florida statutes and addresses the City's expectations for professionalism and preparedness in public-facing positions.

## 5.4 Technology and documentation

- **ProxiGuard compliance:** Centurion officers will use the City's designated time-tracking system at check-in and check-out points.
- **Data logs and audit support:** All shift logs, site inspections, and supervisor check-ins are documented daily and stored for audit purposes. Centurion's central operations team monitors compliance in real time.

## 5.5 Community-first focus

Centurion's security officers are trained to:

- Serve as visible deterrents and approachable resources for visitors
- Identify unusual behavior while avoiding unnecessary confrontation
- Maintain a calm and composed posture in high-traffic and seasonal environments

the shooting of Washington while on the residential property.

b. Based on evidence in in discovery, there is a high likelihood of a verdict of no liability as it is clear from the evidence that Centurion took all precautions necessary, the records reflect that Centurion made all rounds and recorded time and location, and Plaintiff testified that the only way the shooting could have been prevented is if the property owner had hired Opa Locka PD rather than a private security company. The property owner also rejected Centurion's prior recommendation for additional security personnel.

c. UPDATE as of 1/23/2025: Case settled for \$5,000 paid to Washington. Currently waiting for the case to be formally dismissed. Settlement based solely on nuisance value and the economic realities of litigation (and not due to the merits of the claim as the claim lacked merit).

3. Sharika Hightower, on behalf of minor daughter S.B. v. Glorieta Partners, et al. – Case No. 2023-7075 – pending - negligent security.

a. Claim that Centurion was negligent in providing security services by failing to prevent the shooting of Hightower's daughter while on the residential property (same shooting as Washington).

b. Based on evidence in discovery, there is a high likelihood of a verdict of no liability as it is clear from the evidence that Centurion took all precautions necessary, the records reflect that Centurion made all rounds and recorded time and location. The property owner also rejected Centurion's prior recommendation for additional security personnel.

c. UPDATE as of 1/23/2025: Case settled for \$10,000 paid to Hightower. Currently waiting for Court approval since the plaintiff is a minor child. Settlement based solely on nuisance value and the economic realities of litigation (and not due to the merits of the claim as the claim lacked merit).

4. Greg Shine v. Glorieta Partners, et al. – Case No. 2023-26554 – pending - negligent security.

a. Claim that Centurion was negligent in providing security services by failing to prevent the shooting of Shine while on the residential property.

b. Based on evidence in in discovery, there is a high likelihood of a verdict of no liability as it is clear from the evidence that the shooting occurred off of the secured premises. Centurion took all precautions necessary; the records reflect that Centurion made all rounds and recorded time and location. The property owner also rejected Centurion's prior recommendation for additional security personnel.

c. UPDATE as of 1/23/2025: Case ongoing. Case completely meritless. We have a deposition of the plaintiff coming soon. Once taken, Centurion will file a Motion for Summary Judgment.

5. Devisha Viel v. J.A.W. Entertainment – Case No. 2021-16733 – pending – negligent security.

a. Claim that the Centurion was negligent in providing security by failing to prevent the





stabbing of Veil while on the nightclub property.

b. No activity in case since September 2023.

c. UPDATE as of 1/23/2025: Case settled for \$4,000 paid to Viel. Settlement based solely on nuisance value and the economic realities of litigation (and not due to the merits of the claim as the claim lacked merit).

6. Denesha Penick Coles, P.R. v. J.A.W. Entertainment – Case No. 2021-5936 – negligent security – settled on December 15, 2022, for \$7,500.

a. Claim that Centurion was negligent in providing security by failing to prevent the shooting of Andrew Jackson while on the nightclub property.

b. Settlement was paid as a nuisance value settlement and not because Centurion had any liability.

c. UPDATE as of 1/23/2025: Case settled for \$7,500 paid to Coles. Settlement based solely on nuisance value and the economic realities of litigation (and not due to the merits of the claim as the claim lacked merit).

##### Purpose of Form

##### Who Must File

Filers of Form 1120, 1120-C, 1120-F, 1120S, or 1065, must complete and attach Form 1125-A if the applicable entity reports a deduction for cost of goods sold.

##### Inventories

Generally, inventories are required at the beginning and end of each tax year if the production, purchase, or sale of

merchandise is an income-producing factor. See Regulations section 1.471-1. If inventories are required, you generally must use an accrual method of accounting for sales and purchases of inventory items.

**Exception for certain taxpayers.** A small business taxpayer (defined below), can adopt or change its accounting method to account for inventories in the same manner as material and supplies that are non-incidental, or conform to its treatment of inventories in an applicable financial statement (as defined in section 451(b)(3)), or if it does not have an applicable financial statement, the method of accounting used in its books and records prepared in accordance with its accounting procedures. See section 471(c)(3).

A small business taxpayer claiming exemption from the requirement to keep inventories is changing its method of accounting for purposes of section 481. For additional guidance on this method of accounting, see Pub. 538, Accounting Periods and Methods. For guidance on changing to this method of accounting, see Form 3115 and the Instructions for Form 3115.

**Small business taxpayer.** A small business taxpayer is a taxpayer that (a) has average annual gross receipts of \$25 million or less (indexed for inflation) for the 3 prior tax years, and (b) is not a tax shelter (as defined in section 448(d)(3)). See Pub. 538.

**Uniform capitalization rules.** The uniform capitalization rules of section 263A generally require you to capitalize, or include in inventory, certain costs incurred in connection with the following.

- The production of real property and tangible personal property held in inventory or held for sale in the ordinary course of business.
- Real property or personal property (tangible and intangible) acquired for resale.
- The production of real property and tangible personal property for use in its trade or business or in an activity engaged in for profit.

A small business taxpayer (defined above) is not required to capitalize costs under section 263A. See section 263A(i).

See the discussion on section 263A uniform capitalization rules in the instructions for your tax return before completing Form 1125-A. Also see Regulations sections 1.263A-1 through 1.263A-3. See Regulations section 1.263A-4 for rules for property produced in a farming business.

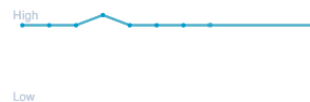

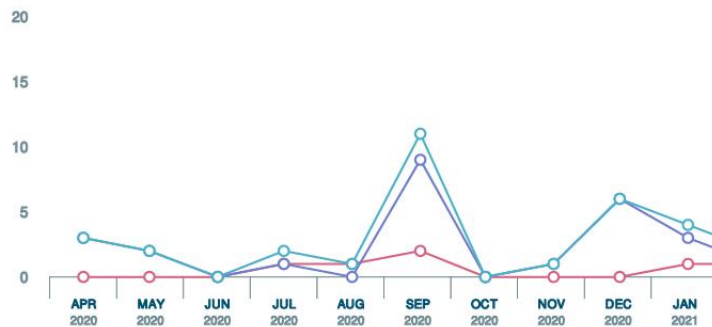
