A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF CHARLEY TOPPINO & SONS, INC. RECEIVED IN RESPONSE TO INVITATION TO BID (ITB) #20-002 FOR SIMONTON STREET IMPROVEMENTS - PROJECT II41021901 (2019 ADA SIDEWALKS) AND PROJECT II41021902 (2019 REPAVING PROGRAM)) IN AN AMOUNT NOT TO EXCEED \$1,435,129.25; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE BID PROPOSAL, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Simonton Street is an important connector for vehicles, bicycles and pedestrians, and this project will repair trench failures, rehabilitate the pavement surface, provide new pavement markings, ADA compliant sidewalks and curb ramps along Simonton Street from Truman Ave to the northern limits of Simonton Street; and

WHEREAS, two bids were received in response to ITB 20-002, with Charley Toppino & Sons, Inc. submitting the lowest bid; and

WHEREAS, City staff finds the lowest bid to be reasonable and responsible, and recommends award of the bid to Charley Toppino & Sons, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the bid of Charley Toppino & Sons,
Inc. is hereby awarded in response to ITB 20-002 for Simonton
Street Improvements, in an amount not to exceed
\$1,435,129.25.

Section 2: That this project is funded from budget
account 102-4102-541-6300 -- Project II41021901 FY 2019 ADA
Sidewalks and Project No. II41021902 2019 Repaving Program,
and any necessary budget adjustments are hereby authorized.

Section 3: That the City Manager is hereby
authorized to execute a contract in substantial conformance
with the bid documents upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
