WHEREAS, three bids were received in response to ITB 23-020, with Air Mechanical & Service Corp. submitting the lowest responsive bid; and

WHEREAS, City staff finds the lowest bid to be responsive and responsible, and recommends award of the bid to Air Mechanical & Service Corp

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the bid of Air Mechanical & Service Corp. is hereby awarded in response to ITB 23-020 for Navy Exchange HVAC Upgrades Project, in an amount not to exceed \$442,000.00.

Section 2: That the project is funded in account 602-1900-519-4600 Project OM19002301 in the amount of up to \$462,000.00. Any additional necessary budget adjustments or amendments are hereby authorized.

Section 3: That the City Manager is hereby authorized to execute a contract in substantial conformance with the bid documents upon consent of the City Attorney.
