A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED SUPPLEMENTAL JOINT PARTICIPATION AGREEMENT NUMBER TWO (SJPA #2) FOR CONTRACT ARB19 BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST, TO AMEND THE MAXIMUM PARTICIPATION OR GRANT AWARD FROM FDOT FROM \$433,406.00 to \$542,452.00, REFLECTING AN INCREASE OF \$109,046.00, TO BE USED FOR OPERATING EXPENSES OF THE FIXED ROUTE BUS TRANSIT SYSTEM; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution No. 14-049, the City Commission approved a JPA (Contract No. ARB19), for grant funding of operating expenses of a fixed route bus transit system, in the amount of \$542,452.00.00, (50% maximum FDOT participation), and additional mutually agreed terms; and

WHEREAS, in Resolution No. 14-124, the City Commission approved Supplemental Joint Participation Agreement Number One, which reduced the grant funding of operating expenses; and

WHEREAS, FDOT advised the City that additional funding has been recovered, and an amendment is required, attached hereto as Supplemental Joint Participation Agreement Number Two, which restores the amount of funding to \$542,452.00, as approved in the original JPA for Contract #ARB19.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached Supplemental JPA Number Two, for FDOT Contract No. ARB19 between FDOT and the City of Key West, for funding of operating expenses for a fixed route bus transit system in Key West as mutually agreed upon by FDOT and City, is hereby approved in the total amount of \$542,452.00, reflecting an increase of \$109,046.00.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
