COMMENTS FOR MEETING OF AUGUST 28, 2025

Dear Planning Director:

Keys Energy Services (KEYS) received the Development Review Committee Agenda for August 28, 2025. KEYS reviewed the items that will be discussed at the City's Development Review Committee meeting.

Below are KEYS' comments:

LOCATION: Minor Development Plan, Conditional Use - 701 Palm Avenue
COMMENT: KEYS has no objection to the Conditional Use request. As noted, KEYS owns and maintains the 69kV transmission line that runs over the property. The construction and future operation of the vertical dry racks must maintain sufficient vertical and horizontal clearances in accordance with the National Electrical Safety Code (NESC) Rule 234, OSHA standards, and other applicable regulations. The DRC package has insufficient detail to determine if the necessary clearances are being maintained. The detailed conditional use submittal should contain specific clearances demonstrating compliance with applicable regulations. Additionally, the overhead lines traverse the area between the proposed racks and existing boat launch point. The Applicant should provide a safety plan illustrating the safeguards which will be implemented to ensure appropriate approach distances will be maintained during the movement of vessels from racks to boat launch point. The safety plan should be considered as part of the conditional use approval process, and approval should be conditioned upon the implementation of the plan.

LOCATION: Major Modification to a Major Development Plan - 1618 N
Roosevelt Boulevard

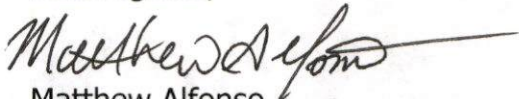
COMMENT: KEYS has no objection to the Major Modification to a Major
Development Plan request. KEYS has three phase overhead
power lines that will service this project. KEYS will need to
have a full set of plans and a project review form to ensure
adequate power is supplied for the new project and the
existing customers.
