A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Tuesday, January 8, 2013.

Mayor Craig Cates called the meeting to order at 6:06 p.m.

City Attorney's Report

Shawn Smith, City Attorney, updated the Commission on the Assisted Care Coalition Lease, the Navy Outer Mole issue and the Waste Management contract.

Mr. Smith stated the Assisted Care Coalition's lease commenced on the 31st of December, 2012. They have 180 days in which to submit a development plan application. The lease under negotiations by the City Attorney's office was ongoing.

With respect to the Outer Mole lease issue, Mr. Smith stated there is a federal provision where the Navy would not have to go out for bid provided certain public benefits are shown. He is drafting a justification paper for the Navy that will show why the City of Key West should be held out as a perfect example of enhanced use lease agreements with governmental entities. He anticipated having a letter out to the Navy within the next two weeks.

Mr. Smith reported on the contract negotiations between the City and Waste Management. They would meeting the following week to address the points the Commission voted on at the last meeting. It would come before the Commission as a formal amendment to the contract.

Mr. Smith mentioned the school crossing guard at the Montessori School, Martha Finch that made and distributed 120 Christmas stockings for the children.

Commissioner Weekley asked about the term limits considering the change in the election cycle.

Mr. Smith stated if the term extended beyond the term limit they would be able to finish their term.

City Manager's Report

Bob Vitas, City Manager, had no report for the Commission. Mayor Cates brought up concerns about the recent shooting at a school in Newtown, Connecticut and the desire for full-time resource officers at the middle school and high school. He asked if the City Manager would work with the Chief of Police to see if they could look into this. Mr. Vitas said he has discussed this with the School Superintendent and would follow up with him, the Police Department and the County Sheriff. Mr. Smith stated he anticipated a resolution on the next agenda so the Commission can have a full discussion on the topic.
