Preferred Drilling Solutions, Inc. (PDS) Contractor, proposes to perform the following scope of work at the referenced job site using OSHA 1910-120 trained employees. The work is to be completed for Tetra Tech.

One Excavation Area

- 1. Scope of Work: - Task # 1- Perform soil excavation, soil loading and staging on one mobilization, approximately 900 tons. One excavation area, as per bid specifications, approximately 3700 SQ Ft. Total to 4 BLS. Provide and install and compact, clean backfill in 1' lifts. 600 Tons. Load out 900 Tons of contaminated soil. Provide and Install #57 Gravel below the water table. Approximately 200 Tons.**
  - A. Mobilize and de-mobilize one time for this project.
  - B. A Notice of Commencement (NOC) will be required, PDS will provide preparation and recording. Others are to obtain owners signatures.
  - C. Provide a 2" water pump and tank, to use for dust control as needed.
  - D. Excavate one area and stock pile, load out, approximately 900 Tons total.
  - E. Provide labor, material and equipment, to excavate and load out one area of contaminated soil. Payment will be from portal to portal. The estimated time to complete the job is 14 days using a 4 man crew, including one mob and including "2" weekends. Based on a 10 hour work day, for excavating, loading and back filling. Labor time includes site preparation and mob/demob to the site.
  - F. Contaminated soil disposal by PDS. Soils sent to Clean Earth. PDS to load out soil, onto trucks provided by PDS, up to 900 tons.
  - G. Backfill and compact the excavation Grade. Compact excavation in 1' lifts to Grade. PDS to provide the clean imported back fill. Provide proctor and Density Tests. Provide and Install # 57 Gravel Below the water table. Provide and install Geo Filter fabric on top of # 57 Gravel, before installing clean backfill.

## II. Payment, Terms and Conditions


A. Cost: The total price including tax for the work covered herein is : Not including T.B.D. Items
