A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RENEWING FOR TWO YEARS THE GENERAL ENGINEERING SERVICES CONTRACTS WITH SEVEN (7) FIRMS, ORIGINALLY AWARDED IN RESOLUTION 23-029 IN RESPONSE TO REQUEST FOR QUALIFICATIONS NO. 22-006 FOR GENERAL ENGINEERING SERVICES; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 23-029 the City Commission approved seven (7) engineering firms to provide General Engineering Services for the City of Key West, and authorized the City Manager to negotiate three-year contracts with the option of a two-year renewal at the option of the City; and

WHEREAS, City staff recommends exercising the two-year renewal option for each engineering firm; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the contracts for General Engineering Services are hereby renewed for an additional term of two (2) years under the same terms and conditions as the original agreements, for the following seven (7) firms:

- (2) Tetra Tech
- (3) Perez Engineering & Development, Inc.
- (4) Stantec
- (5) Artibus
- (6) KCI Technologies
- (7) BCC Engineering Group

Section 2: That the City Manager is hereby authorized to execute any necessary documents, upon the advice and consent of the City Attorney.

Section 3: Specific task orders issued pursuant to the contracts shall continue to comply with the City's procurement guidelines.



Introduction

Approve a two (2) year extension of General Engineering Services Contracts through February 29, 2028, in accordance with the terms of the contract for below listed firms and authorize City Manager to execute the extensions.

Background

In 2022, staff issued RFQ 22-006: *General Engineering Services* to competitively solicit qualified Engineering firms for Professional Engineering Services. Resolution 23-029 awarded three-year General Engineering Services contracts to the below listed companies and contracts were fully executed on March 1, 2023.

2. Tetra Tech
3. Perez Engineering & Development, Inc.
4. Stantec
5. Artibus
6. KCI Technologies
7. BCC Engineering Group

In accordance with Article 4 of the agreements, there is an option for a single two (2) year renewal. The City has several ongoing capital projects with most of the firms.

Procurement

Contracts are issued on a task order basis. Financial implications of this resolution are limited to an adjustment of hourly rate fees as allowed in Article 5 of the agreements.

RESOLUTION NO. 23-029

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING STAFF RANKING AND AWARDING CONTRACTS ON A TASK ORDER BASIS TO SEVEN FIRMS IN RESPONSE TO REQUEST FOR QUALIFICATIONS NO. 22-006 FOR GENERAL ENGINEERING SERVICES; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE A CONTRACT WITH EACH VENDOR IN SUBSTANTIAL CONFORMANCE WITH DOCUMENTS IN THE RFQ, AND UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City issued a Request for Qualifications for engineering firms capable of providing general engineering services; and

WHEREAS, the City engages in simultaneous projects of varied scope, and typically contracts with multiple firms, to be able to address the workload and diverse service area specialties that may be required; and

WHEREAS, twenty firms responded, and at a public meeting on December 21, 2022, a committee comprised of City staff members reviewed the responses, and determined the seven highest scoring full-service firms to be particularly qualified, and recommended that the City engage each one on a Task Order basis;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the responses for general and utility engineering consulting services are hereby ranked by staff, and approved by the City Commission as follows:

- (1) Jacobs Engineering Group, Inc.
- (2) Tetra Tech, Inc.
- (3) Perez Engineering & Development
- (4) Stantec Consulting Services, Inc.
- (5) Artibus Design, LLC
- (6) KCI Technologies, Inc.

Section 2: That the City Manager is hereby authorized to negotiate and execute contracts with each of the companies, in substantial conformance with documents contained in the RFQ, and upon advice and consent of the City Attorney, for a term not to exceed three (3) years, with an option for one two-year extension.

Section 3: Specific task orders issued pursuant to the contracts shall comply with the City's procurement guidelines.



Action Statement

Approve staff ranking of firms submitting responses to RFQ 22-006: General Engineering Services and authorize City Manager to negotiate and, pursuant to legal review, enter contracts with selected engineering firms.

Background

The City of Key West (City) requires the services of qualified firms to provide a range of Engineering Services, including but not limited to planning, design, permitting assistance, bid and proposal development, and services during construction. The City issued RFQ No. 22-006: General Engineering Services on October 26, 2022. Qualification packages were opened on December 7, 2022. The City received 20 responses to the RFQ from the following. Upon review of received qualifications, all firms were considered responsive and responsible.

On December 21, 2022, a selection committee of City Staff held a publicly advertised meeting to present qualification ranking of the twenty firms submitting qualifications in response to the RFQ. Selection committee qualification rankings are attached for review.

Using the Selection Criteria Matrix in the RFQ, the selection committee developed a list of the following firms in highest to lowest ranking order as shown below.

Purpose and Justification

The City typically contracts with multiple firms, and this grouping will be able to address the varied scope and workload for multiple departments within the City. Initially, six firms were to be selected, but KCI Technologies and BCC Engineering Group shared the same score. These seven recommended firms all scored 85% (rounded) and can provide the City with the necessary diversity in service area specialty, size/capacity and local presence to address anticipated needs with future projects.

The term of contracts shall be for a period of three (3) years with the option of one (1) two (2) year renewal.

This resolution supports Key West Forward Strategic Plan Adaptation goal 2.5 *Critical Infrastructure Projects, Roads and Sidewalks* goal 1.8 *Develop Shovel Ready Projects*, Environmental Protection goal 2.8 *Electric Charging Stations*, Environmental Protection goal 3.1 *Sediment Separators on Outfalls*, Environmental Protection goal 3.6 *Evaluate Wastewater and Sewer Systems for Repair*, Traffic & Pedestrians Friendliness goal 1.7 *Sidewalk Repair*.

Financial

There are no financial obligations with ranking and entering into contracts with each of the listed firms. Project assignments will be task order based with a respective fee approved for each task order per City Ordinance.

Recommendation

The selection committee recommends the City Commission review the staff ranking and evaluation of the firms and authorize City Manager to negotiate and, pursuant to legal review, enter into contracts with the seven firms.
