A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AMENDING RESOLUTION 22-189 FOR THE ON POINTE RESTAURANT GROUP, LLC DBA LA TRATTORIA VENEZIA TO ALLOW A CHANGE OF DATES FROM THURSDAY, NOVEMBER 10, 2022 FROM 5:00 P.M. TO 10 P.M. TO FRIDAY, NOVEMBER 18, 2022 FROM 5:00 P.M. TO 10:00 P.M. ON APPLEROUTH LANE BETWEEN DUVAL STREET AND WHITEHEAD STREET ON FRIDAY, NOVEMBER 18, 2022 FROM 5:00 P.M. TO 10:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FOR THE EVENT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS On Pointe Restaurant Group, LLC DBA La Trattoria Venezia has applied to the city for a Special Event Permit for their 40th Anniversary on Friday, November 18, 2022, from 5:00 p.m. to 10:00 p.m. on Telegraph Lane.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West Florida.

SECTION 1. That in Resolution 19-174, the City Commission directed the city Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law”

SECTION 2. “That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore

commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and “To go” packages for food or products sold on any property leased from the City”

SECTION 3. That On Pointe Restaurant Group, LLC DBA La Trattoria Venezia is hereby given permission to conduct their event during the date and time specified above.

PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that organization meets the terms and conditions set forth by the City Manager

SECTION 4. That On Pointe Restaurant Group, LLC DBA La Trattoria Venezia is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time as herein described.

SECTION 5. That pursuant to Section 18-86 of the Key West Code of Ordinance the On Pointe Restaurant Group, LLC DBA La Trattoria Venezia is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 6. That On Pointe Restaurant Group, LLC DBA La Trattoria Venezia must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age. Proof of compliance with Supplement F, paragraph 3 of the application is required at least ten (10) days in advance.

SECTION 7. That On Pointe Restaurant Group, LLC DBA La Trattoria Venezia will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 8. That the applicant acknowledges this authorization may be revoked by the Commission or the City Manager, due to exigent circumstances such as the resurgence of COVID-19 in the community.

SECTION 9. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
