A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING MARQUES BUTLER MEMORIAL SCHOLARSHIP, INC. TO CONDUCT A FUNDRAISER AT THE CLAYTON STERLING COMPLEX AND THE DEWITT ROBERTS FIELD FOR THE ANNUAL MARQUES BUTLER MEMORIAL SOFTBALL TOURNAMENT ON FRIDAY, FEBRUARY 17, 2017 THROUGH SUNDAY, FEBRUARY 19, 2017 FROM 7:00 A.M. TO 11:00 P.M. PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE OFFICE OF THE CITY MANAGER; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 7:00 A.M. TO 11:00 P.M DURING THE EVENT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES ON THE DATE AND DURING THE HOURS STATED ABOVE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Marques Butler Memorial Scholarship, Inc. wishes to conduct a fundraiser for the Marques Butler Memorial Softball Tournament on the date and during the hours stated above to benefit a Key West High School Senior;

NOW THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida:

SECTION 1. That the Marques Butler Memorial Scholarship, Inc. is hereby granted permission to conduct a Fundraiser on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and the organization meet the terms and conditions set forth by the City of Key West and that 100% of the money collected shall be donated to the Marques Butler Memorial Scholarship Fund to benefit numerous Key West High School Seniors.

SECTION 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, the Marques Butler Memorial Scholarship, Inc. is hereby granted permission to allow the sale and consumption of alcoholic beverages.

SECTION 3. The Marques Butler Memorial Scholarship, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. The Marques Butler Memorial Scholarship, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrel will be used and that they will be placed side by side.

SECTION 5. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
