Lawful Unit Determination

Dear Mr. Moss,

The purpose of this letter is to respond to your request that the Planning Department reevaluate a previous unit count determination from 2011 regarding the property at 712-716 Eisenhower Drive and 703 – 705 Pearl Street, Real Estate Number 00023300-000000.

At the time of that review, based on available records, the Planning Department identified eleven legal units out of a total of twelve existing prior to 1990 on the site. According to newly available information, the twelfth unit can be considered legal. Attached are copies of a Polk Directory ca. 1987 identifying 703 Pearl Street and a 1988 Finance Department receipt showing a City Utilities Account for twelve units on the site. The common address for the site is 716 Eisenhower Drive. However, the twelfth unit is considered to be at 703 Pearl Street.

In summary, this letter establishes that twelve non-transient residential units exist on the property. This letter does not grant unit allocations, but rather recognizes twelve existing non-transient residential units on the property. Subsequently, this document will be sent to the Department of Economic Opportunity (DEO) for their review. It is possible that the DEO may object to or provide direction regarding these findings.
