

**MINUTES**  
**CITY COMMISSION MEETING**  
**OLD CITY HALL, 510 GREENE STREET**  
**TUESDAY, JUNE 15, 2010**

A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Tuesday, June 15, 2010.

Mayor Craig Cates called the meeting to order at 6:00 p.m.

The pledge of allegiance to the flag of the United States of America was given by all present.

**CHANGES TO THE AGENDA**

Commissioner Weekley requested Item 10 regarding Kessler Consulting be placed on the consent agenda.

Without opposition, the agenda was accepted as changed.

## **PRESENTATIONS:**

External Auditor – Fiscal Year Ending 2009

City Manager Jim Scholl introduced the Auditors Bill Benson and Israel Gomez to give the report.

City Attorney's Report

City Attorney Shawn Smith updated the Commission regarding the "Dog Ordinance". The Planning Board approved this item at their last meeting and it will be on the next agenda for first reading before the Commission. Mr. Smith thanked his staff for their work.

City Manager's Report

City Manager Jim Scholl updated the Commission regarding the oil spill in the Gulf of Mexico. He said there would be a weekly command meeting held the next day and he will get the latest local updates at that time. Conditions remain unchanged.

Mr. Scholl stated there is a task order out for an extensive environmental look at the Glenn Archer School building. They are moving forward with moving personnel from the Madeline Bean Building to Habana Plaza. They will be ready to go on Monday morning June 28, 2010 at the Habana Plaza offices. The Finance Department is anticipated to move before the end of August. As the final build out is completed the offices at City Hall will move out.

Mr. Scholl stated there is a special event on Sunday morning. The Hooka Hay Motorcycle Challenge will be departing from the Marriott Beachside Hotel in Key West to Homer, Alaska.

Commissioner Weekley asked about the BP claim center and business losses. He asked if the City would be able to place a claim for loss of revenue due to the loss of sales taxes. Mr. Scholl stated there would have to be financial data to say they would have a documented loss to seek any damages.

City Attorney Smith stated BP has a separate claims process set up for governmental entities.

Commissioner Gibson asked for information regarding Wisteria Island. Mr. Scholl said there are issues that would need to be resolved but it would be determined on how the County proceeds. As information becomes available he would update the Commission.

Shawn Smith, City Attorney, stated in reviewing the ordinance he would recommend changes in the first whereas clause to read "Whereas the City Commission finds that updated regulations consistent with the exception provided by Florida Statute section 800.03 would promote the health, safety and welfare of the citizens of Key West" and the second recommendation would be a second whereas clause to make clear what the Commission's intent is to read "Whereas the intent of this ordinance is to protect and preserve the health, safety and welfare of the people of Key West by prohibiting any person from appearing nude in a public place, subject to an exception for those areas set aside for such purpose." Mr. Smith suggested under (a) Definitions that the following sentence be added, "A mother's breastfeeding of her baby does not violate this section" as this is consistent with the State Statute. He also suggested additional wording after the description of public place to include ". . . and an individual does not have a constitutionally protected expectation of privacy." The final suggestion would be under section (d) Exemptions, and that would be to add after the word Resolution "or ordinance".
