## Contract

The Contractor, in consideration of the sum to be paid him by the Owner and of the covenants and agreements herein contained, hereby agrees at his own proper cost and expense to do all the work and furnish all the materials, tools, labor and all appliances, machinery and appurtenances for ITB # 18-014 City Fuel Supply, to the extent of the Bid made by the Contractor: dated this 26<sup>TH</sup> day of APRIL 2018, all in full compliance with the Contract Documents referred to herein: BIDDING REQUIREMENTS, SCOPE OF WORK, CONDITIONS OF THE CONTRACT, CONTRACT FORMS, which consists of City Fuel Supply are referred to and by reference made part of this Contract as fully and completely as if the same were fully set forth herein and are mutually cooperative therewith.

In consideration of the performance of the work as set forth in the Contract Documents, the Owner Agrees to pay to the Contractor the amount in the Bid as adjusted in accordance with the Contract Documents, or as otherwise herein provided, and to make such payments in the manner and at the times provided in the Contract Documents.

The Contractor agrees that the Contract period shall be for five (5) years. The Contract shall begin on the date the Contract was entered into.

Any action brought to recover damages or otherwise enforce this agreement shall be brought in Monroe County, Florida. In any such action, the prevailing party shall be entitled to reasonable attorney fees at all trial and appellate levels. Nothing herein shall be construed as waiving the City's rights of Sovereign Immunity pursuant to Section 768.28 Florida Statutes.

I would like to thank you for your invitation to bid on the City Fuel Supply ITB # 18-014.

We will supply Marathon Petroleum branded product as called for by the bid. The **guaranteed allocation** associated with supplying branded product was incredibly valuable during the Hurricane Irma aftermath. Marathon branded signs will be supplied for the Marina. Currently, there is not a reliable source for QUALITY CONTROLLED Bio diesel fuel available at Pt Everglades Terminal. Although currently unavailable, if the product becomes available by a reputable source, we will notify the City personnel about purchasing it at that time.

All freight related costs are included in the Bid Response Forms with the exception of the freight fuel surcharge. In January of 2000, the freight industry began levying a fuel surcharge due to the high prices of fuel. This surcharge is based on the US Energy Information Administration East Coast Lower Atlantic average on-highway diesel fuel price which changes each Monday. This surcharge will be listed as a separate line item rather than be included in the per gallon freight charge. This surcharge is not reflected in the attached Bid # 18-014.

I truly hope that we have the opportunity to continue serving the City with its fuel needs. It has been a pleasure working with everyone there. If you have any questions or need further clarifications on any of the enclosed information, please feel free to contact me.
