A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDING THE BID OF CHARLEY TOPPINO AND SONS INC. FOR THE DONALD AVENUE AND 16<sup>TH</sup> TERRACE STREET PAVEMENT STABILIZATION IN AN AMOUNT NOT TO EXCEED \$ 107,850.00 IN ACCORDANCE WITH THE TERMS SPECIFIED IN ITB 15-016; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AND PURSUANT TO LEGAL REVIEW ON BEHALF OF THE CITY OF KEY WEST; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on April 22, 2015 two bids were opened in response to ITB 15-016 for Donald Avenue and 16<sup>th</sup> Terrace Street Pavement Stabilization and all of the bids were responsive; and

WHEREAS, the lowest responsive bid was submitted by Charley Toppino and Sons, Inc., and the bid was reviewed and recommended by Staff; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Charley Toppino and Sons, Inc. for the Donald Avenue and 16<sup>th</sup> Terrace Street Pavement Stabilization in response to ITB 15-016 is hereby awarded in the base bid amount of \$ 107,850.00.

Section 2: That the City Manager, upon consent of the City Attorney, is authorized to execute a contract in substantial conformance with the bid documents on behalf of the City of Key West.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
