- 8** Approval of Ordinance Revision to Section 110-327 of the Code of Ordinances.
- 3 motions were made by Commissioner Denise Bravo, seconded by Commissioner Billy Davis:**
- The first one requesting an Ordinance revision with Section 110.331, creating a new Section D adjusting the caliper inch ratio to a 4:1 credit, as incentive to plant 8 protected canopy trees in the City of Key West, including Gumbo Limbo, Royal Poinciana, Strangler Fig, Short Leaf Fig, Sapodilla, Spanish Lime, Jamaican Dogwood and Mahogany trees, in place of the word which currently reads "canopy trees".**
- A second motion is a Resolution to increase the fee for replacement inch in lieu of fees for canopy trees from \$150.00 to \$200.00 per caliper inch, not including the 8 previous canopy trees.**
- A third motion is for a new Ordinance regarding unfulfilled permits being referred to the Special Magistrate and moving it to a different area of the code.**
- The motions all passed by an unanimous vote.**
