Dear Members of the Selection Committee:

Greenberg Traurig, LLP ("Greenberg Traurig," "GT" or the "Firm") is pleased to present this proposal for professional federal lobbying services to the City of Key West, Florida ("Key West" or the "City"). We look forward to discussing how our capabilities and experience will benefit the City.

Greenberg Traurig, LLP is an international, multidisciplinary law firm with 1,800 attorneys and governmental affairs professionals serving clients from over 30 locations in the United States, Europe and Asia. Over the past 45 years, the Firm has grown rapidly, expanding from its strong local roots in South Florida to a global law firm with over 3,500 employees. The Firm's experience in more than 100 practice areas and its network of contacts in the United States and abroad make GT well-positioned to help its clients achieve their objectives both domestically and globally.

GT's Governmental Affairs practice routinely work with state and federal agencies to identify sources of funding as well as to assist clients in navigating the complex web of local, state and federal regulations and regulators. We have successfully assisted clients in identifying and obtaining sources of funding at the state and federal levels, led them through the grant process, assisted in obtaining necessary permits and, when necessary, assisted the clients with contractual issues.

We are familiar with the issues facing the City of Key West, and understand how local issues translate to federal opportunities. GT has identified the following eight issues of critical importance to the City.

- 1. Economic Development. GT understands the City's on-going economic objectives regarding the Truman Waterfront, harbor improvements and related community needs, such as water quality improvements and service worker housing. We believe that a multi-prong strategy is critical to supporting the City's diverse needs at the federal level in order to maintain Key West as a premier tourist destination.
- 2. Water Quality/Infrastructure. We recognize water quality as one of the most important factors in maintaining a sustainable, tourist-based economy. Stormwater and wastewater treatment improvements and recurring maintenance are costly programs which should be supported through state and federal programs. It is not sufficient to simply pursue Section 129 funding through the Army Corps of Engineers. GT will aggressively pursue broader sources of funding, leveraging the Key West Area of Critical State designation to support funding at the federal level.
- **3. Disaster Recovery and Redevelopment.** Key West will continue to experience hurricanes and periodic flooding. Like many of these issues, emergency management involves a close partnership between federal and state programs. We routinely work with these programs and are very familiar with the issues impacting Key West.

- **4. Transportation.** GT has wide ranging experience in developing and implementing funding strategies for major transportation projects. While the North Roosevelt project is underway, Key West is potentially one storm away from an emergency need to expedite reconstruction of the Cow Key Channel bridge. We can assist the City in planning for this type of event and in securing funding through the reauthorization of SAFETEA for its transit and mobility needs. We believe that Key West should pursue federal support for a "complete streets" program that would benefit mature communities, such as Key West, where mobility enhancements rather than extensive capacity improvements, are needed.
- **5. Beach Renourishment/Shoreline Improvements.** GT has substantial experience in permitting beach renourishment and shoreline improvement projects at both the state and federal level. As the City's Climate Action Plan recognizes, these types of permitting issues will pose increasing challenges as sea level rise impacts the Keys.
- **6. Military Base Related Issues.** We recognize that military installations continue to be a significant consideration in maintaining Key West's housing stock. While the City has maintained a positive working relationship with the military through the BRAC process, military coordination will continue to present opportunities at the federal level. Team member Joe Corrigan served as the Army's point person on Capital Hill for Base Realignment and Closure (BRAC), land conveyances, and Army leasing programs, and also led the Army command responsible for the environmental documentation for all Army BRAC actions as well as a command responsible for disposing of real estate made excess by BRAC.
- **7. Affordable Housing.** The Key West economy depends on functional service worker housing as well as workforce housing for police, nurses and other service providers that are vital to the safety of any community. GT understands the housing delivery process from a public and private sector perspective and has extensive experience in working with public officials and private developers to obtain state and federal funding.
- 8. Permitting Issues. Many of these priorities will continue to require permitting at the federal level. Key West's natural resources warrant a careful permitting approach that achieves the City's economic objectives, while maximizing environmental protection. Effective representation at the federal level can also avoid unnecessary problems, such as the recent permitting issues with USFWS and FEMA related to listed species mapping. Proactive communications are critical in such situations and depend on well established relationships with the regulators. Rather than react to a problem, effective representation would ensure that the City is aware of the federal mapping exercise, engages the agencies at the front end, and avoids a misunderstanding. GT has a strong land development and environmental practice group that routinely assists clients with Corps of Engineers Civil Works projects and in obtaining Corps of Engineer permits under both the Clean Water Act and Rivers and Harbors Act.

We understand that priorities evolve and that certain issues may become critical at a given point in time, but we firmly believe that a structured framework is essential for managing short term priorities, while pursuing longer term objectives. Our legislative team will aggressively identify opportunities for additional federal revenue to the City from the many programs which exist throughout the Federal Government. In this regard, we monitor publications identifying grants and funding opportunities. We also maintain extensive communications with appropriate Congressional and Executive officials and staff to ensure we receive relevant information in a timely manner. Our monitoring and knowledge of federal agencies and programs will allow us to provide the City with options on diverse funding opportunities in departments and agencies that would not likely be found by other firms that do not have the broad practice areas of Greenberg Traurig. Greenberg Traurig also understands that policy initiatives undertaken by the federal government

Joe Corrigan is currently working with the Town of Palm Beach to develop a satisfactory solution to the disposal of dredged material as well as to obtain federal cost sharing on the upgrade of a sand transfer plant. This project requires coordinating cost sharing of ongoing dredging as well as changing the cost sharing arrangement for the future. Our 18-year representation of Miami-Dade County has been a fiscal and policy success. Annually, Greenberg Traurig is tasked with specific appropriation assignments and policy issues to lobby. We have

secured over \$300 million in Congressional earmarks spanning a variety of areas for Miami-Dade County. In addition to providing funding assistance, our federal team assists the County in facilitating meetings and strengthening their relationships with Members of the Florida Congressional delegation.

A summary of the funding achieved on their behalf is as follows:

- Environmental: Miami-Dade's primary environmental concerns are the Everglades, environmental restoration and dredging of the Miami River, beaches, and coastline. After a vigorous campaign we succeeded in having maintenance funding for the County's beach projects included in the President's budget request.
- Transportation and Infrastructure: This category includes aviation, a railway extension, bus purchases and enhancements, traffic mitigation, bridge replacement, highway improvements and other surface transportation projects.
- Economic Development: We have worked on a variety of projects that have brought significant economic benefits to the County including a performing arts center, pedestrian plaza, and activity center.
- Dredging of Miami River: This was a multi-year project of a low use port with heavily contaminated dredge material. The project is now complete. In order to expedite completion we used Corps authorities such as their ability in certain circumstances to reimburse local sponsors who advance a project funding.

Commerce City, Colorado

Greenberg Traurig has provided federal representation services to Commerce City, Colorado, for the past two years. Our representation focuses primarily on appropriations, legislative authorizations and related issues. As part of this representation, we have organized meetings for the City's elected officials with several members of the Colorado delegation which resulted in a raised awareness of the critical issues facing Commerce City. Also, Greenberg Traurig has facilitated meetings between members of Commerce City's administrative leadership and the federal executive branch in order to advocate for the provision of additional resources to develop a new entertainment park which would abut a national wildlife refuge.

During the brief representation of this client, our efforts have led to the inclusion of a congressionally directed spending request totaling \$400,000 for police equipment enhancements. The request was included in both the House and Senate Commerce, Justice, and Science Appropriations bills for FY 2011.

GT is working on a number of projects for El Paso. In the last two years we have assisted in obtaining Corps of Engineer permits around the country for a range of large projects. These include Ruby, a 680 mile, 42-inch interstate gas pipeline connecting Opal, Wyoming with existing gas infrastructure near Malin, Oregon. This project included literally thousands of crossing regulated by three different Corps divisions and numerous districts. We also worked with El Paso on the 300 line in Pennsylvania. This project, which recently was placed into service, required permits from two different Corps districts. We are also assisting El Paso on the Epic site in New Jersey This was a location where the Corps disposed contaminated dredged material in a wetland in the 1950s. The site became part of El Paso's holding later. We obtained all required permits for the clean-up of the wetland and eventual construction of a gas fired electrical generation system in the last

year. This permit required extensive coordination with the Corps at the District, Division, Headquarters level as well as working with the Corps Institute for Water for Water Resources on a challenging policy issue.

Environmental & Infrastructure Issues.

GT represents a number of clients with environmental and infrastructure issues. We routinely work with state and federal agencies to identify sources of funding as well as to assist clients in navigating the complex web of local, state and federal regulations and regulators. We have successfully assisted clients in identifying and obtaining sources of funding at the state and federal levels, led them through the grant process, assisted in obtaining necessary permits and, when necessary, assisted the clients with contractual issues. Following are representative examples which highlight our experience in these areas.

- Our team represented Bexar Metropolitan Water District in federal appropriations matters to secure funding for water infrastructure improvement projects. One matter included working with SAWS to secure funding for Fluoride Expenses through CDC's Oral Health program.
- Our team advocated on behalf of a municipal client for federal funding of an improvement to the waste water plant that allowed reuse of the treated effluent. The project was required because of federal and state limits on the amount of freshwater available to South Florida communities.
- We are involved with developing a model procurement code for one of the nation's largest municipal water systems. This code and the model contracts we are preparing should allow more uniform contracting as well as full compliance with numerous local and federal laws.
- GT has had extensive involvement in working with federal agencies to obtain water from federal projects for local use.
- Over the years, GT has implemented extremely successful strategies to secure funding for beach renourishment in Miami-Dade County. Working in conjunction with the County, similar beachfront communities, and other interested groups such as the American Shore and Beach Preservation Association and the Congressional Coastal Caucus we have worked to pass legislation ensuring continued long-term funding of beach renourishment projects. These efforts have culminated in significant wins for the County's renourishment efforts. Most impressively, we have worked with the Executive Branch to have funding for restoration of a majority of County's beaches included in the President's Fiscal Year 2012 budget request.
- On behalf of Miami-Dade County, we have been instrumental in the restoration of the Florida Everglades. Federal agencies began ecosystem restoration activities in the Everglades more than 15 years ago. However, it was not until 2000 when the Florida Delegation, Congress, the Administration and Greenberg Traurig worked to integrate restoration did real change occur. Coordination among all stakeholders yielded an authorization for a 30-year, \$7.8 billion restoration plan.
- Greenberg Traurig, as lead environmental and land use counsel for the Diplomat redevelopment project in Hollywood, Florida, secured federal and state authorizations to address an erosional hot spot through a beach restoration effort in advance of Broward County's implementation of the Segment III project, as well as authorizations to construct bulkhead and seawall improvements for the resort. - We obtained a permit from the Army Corps of Engineers to construct a seawall to the edge of the federal channel. This permit allowed a South Florida boat yard to expand in order to handle larger vessels. The permit was critical to a project that will add more than 300 high paying jobs in South Florida.
- A member of the GT team worked on the authorization and construction of a series of seawalls that protect the shores in Southern Mississippi. This project, authorized and funded under the Army Corps of Engineers Continuing Authorities Program, allowed three coastal counties to restore their seawalls and the shores which were damaged by hurricanes.
- A member of the GT team led an interagency team for the beneficial use of dredged material. The efforts led to the construction of a large coastal marsh adjacent to a barrier island thus improving habitat and providing storm damage reduction. This project was funded by the federal government with the state government cost sharing a portion of the project's cost.
- Greenberg Traurig worked to pass legislation to correct mapping errors in the Coastal Barriers Resources
 System as part of the Omnibus Parks Legislation for a private client.

Some Examples of Successful Federal Funding

- Secured over \$29.5 million appropriated for major transit multimodal corridor projects for a major municipality.
- Secured more that \$25 million to renourish approximately 8,000 feet of severely eroded shoreline in Miami-Dade County and provide a field test of potential new materials. This funding was provided through the annual Energy and Water Appropriations bills. In addition, the Fiscal Year 2011 Energy and Water Appropriations Bill includes another \$11 million.
- Secured \$15 million in appropriation funds to facilitate the flow of incoming and outgoing traffic to an
 entertainment venue, alleviating traffic congestion and bringing greater economic prosperity to the
 area.
- Secured \$15 million in the Customs Appropriations Bill for a High Energy X-Ray Inspection System to combat cargo theft at the Port of Miami.
- For a municipal client, secured \$5 million in federal appropriations for a railroad cut for a northeastern city's economic development project.
- For a municipal client, secured \$5 million in federal appropriations for a major economic development project in the center of the City.
- Secured \$4.2 million grant from the Federal Aviation Administration to build a replacement control tower at airport in Miami Dade County.

Greenberg Traurig's team is committed to Key West. We have the resources and availability and we will do whatever it takes to "get the job done." Our legislative team aggressively identifies opportunities for additional federal revenue to the City from the many programs which exist throughout the Federal Government. In this regard, we monitor publications identifying grants and funding opportunities on a daily basis. We also maintain extensive communications with appropriate Congressional and Executive officials and staff to ensure we receive relevant information in a timely manner. Our approach and experience in securing funds is two-fold:

- First, we work closely with Members of Congress, agency and White House officials and their staffs in an effort to ensure that the programs which would benefit Key West are fully funded.
- Second, we work closely with our municipal clients at each stage of their applications in an effort to secure prompt approval. In assisting our clients to obtain federal funds, we evaluate each application on three levels – administrative, technical and political.

Also, we can provide the City with updates on diverse funding opportunities from the government. We have and will contact agency officials on the City's behalf to fight for the release of federal funds and will work with the City's Congressional delegation to ensure that appropriated dollars are brought home to the City.

Greenberg Traurig will assist the City in developing a legislative agenda to promote and protect its interests. At the outset, Team Leader Diane Blagman will meet with officials in the City to assess priorities and formulate a strategic plan, objectives and timelines. GT believes that a federal representative's job is to develop a strong working relationship with the client's Congressional delegation. This will assist in accomplishing policy changes as well as gathering congressional support for any of the City's federal funding applications. With these political realities and approaches in mind, Greenberg Traurig's federal representative schedule for the City would be as follows:

Month	Activity
January	Greenberg Traurig (GT) meets with City elected officials and municipal departments to discuss federal subject areas and federal funding needs and/or pending federal funding applications. April – July	Congressional appropriations process begins in earnest. GT schedules a "Key West Day." There, the City's chosen delegation and GT meet with key members of the House and Senate to discuss the City's priorities and any outstanding federal funding applications submitted to any agency. GT will draft letters of support for the Congressional Delegation to send to any agency considering a federal funding application submitted by the City. Throughout this period, GT will advance any policy priority identified by the City.
August	Congress recesses for Summer District work period. GT continues to meet with staff from the Congressional Delegation to advocate for the City's policy priorities.
September – December	September 30, fiscal year ends. Majority of appropriation bills passed by both houses and signed into law. As Congress nears the end of session, legislative activity is expedited. This provides additional opportunities to accomplish policy goals. GT will identify these opportunities and continue to gather support for any federal funding applications submitted by the City. GT begins to work with the City to prepare for the next legislative session. GT reports on all session wins.

Key West would be afforded the full services of our Federal Governmental Affairs team as soon as a contract is signed. In addition, we would draw upon the expertise of other GT colleagues as needed on behalf of the City. Assistance for our teams would be provided by the GT Governmental Services support professionals, a group dedicated to serving the needs of our lobbyists and their clients.
