A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT DATED JUNE 19, 2019 APPROVED BY THE CITY MANAGER AS PROVIDED FOR UNDER SECTION 2-797(2) and 2-797(4) OF THE CODE OF ORDINANCES, FOR RING POWER CORPORATION IN AN AMOUNT NOT TO EXCEED \$72,738.00 TO PROCURE A CATERPILLAR 350 KW 3-PHASE DIESEL GENERATOR FOR THE KEY WEST POLICE DEPARTMENT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the generator at the Key West Police Station is inoperable, and after evaluation, City staff determined that it would be more cost-effective to purchase a new generator, than to continue renting a temporary generator, while elusive replacement parts are located over an indefinite time frame; and

WHEREAS, three price quotes were obtained for a generator with adequate capacity to meet the needs of the KWPD, and Ring Power provided the lowest bid; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize and procure the generator to support essential operations at the KWPD in the event of a power failure; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached emergency task order dated June 19, 2019 by the City Manager, pursuant to section 2-797(2) and 2-797(4) of the Code of Ordinances, to procure a Caterpillar 350 KW 3-Phase Diesel Generator from Ring Power Corporation in an amount not to exceed \$72,738.00 is hereby ratified.

Section 2: That this task order will be paid from budget line General Fund/Police Department/Machinery and Equipment Account 001-2101-521-6400, through a transfer from the City Manager Contingency Fund, and any necessary budget adjustments are hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
