A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A PURCHASING EXCEPTION PURSUANT TO SECTION 2-797 OF THE CODE OF ORDINANCES, TO ALLOW CUMULATIVE EXPENDITURES DURING FY 13-14 TO ENVIRONMENTAL PRODUCTS OF FLORIDA FOR STREET SWEEPER REPAIR AND SERVICE PARTS IN A TOTAL AMOUNT NOT TO EXCEED \$52,500.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, Environmental Products of Florida supplies repair and service parts for three street sweepers, each of which have experienced unanticipated catastrophic equipment failures in the past 60 days; and

WHEREAS, fully operational street sweepers are essential to maintaining clean and safe streets in the City of Key West; and

WHEREAS, the City Manager finds that pursuant to section 2-797(4), it is in the best interest of the City to authorize an expenditure in excess of \$20,000.00 for repair and service parts provided by Environmental Products of Florida.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the expenditure of funds in excess of \$20,000.00, but not to exceed \$52,500.00, to Environmental Products of Florida is hereby authorized in accordance with Key West City Code of Ordinances section 2-797(4)(b).

Section 2: That blanket purchase order No. 75481 is authorized to be increased from \$17,500.00 to \$52,500.00, and necessary budget amendments are authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
