A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER UNDER THE CITY'S GENERAL UTILITIES CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$222,809.12 FOR GENERATOR REPAIRS AT THE RICHARD A. HEYMAN ENVIRONMENTAL FACILITY; AUTHORIZING NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 15-292, the City Commission approved a three-year General Utilities contract with Charley Toppino & Sons, Inc., and in Resolution 18-322 the contract was renewed for two years; and

WHEREAS, Hurricane Irma made landfall in Key West on September 10, 2017, causing significant damage to the generator at Richard A. Heyman Environmental Facility through moisture damage by wind-driven rain; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Task Order under the City's General Utilities Contract with Charley Toppino & Sons, Inc. in a total amount not to exceed \$222,809.12, for Generator Repairs at the Richard A. Heyman Environmental Facility is hereby approved.

Section 2: That a budget transfer from Utilities/Sewer/Reserve Account No. 401-3501-535-9900 to Utilities/Sewer/CIP account No. 401-3504-535-6500, Project HU1701F02-5356500, in the amount of \$222,809.12 is hereby authorized (This project has been submitted for partial FEMA and State reimbursement in the amount of \$161,297.68.)

Section 3: That the City Manager is authorized to execute any necessary documents for this Task Order, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
