
REQUEST: Property owner is seeking removal of (1) Sapodilla Tree (Manilkara zapota).



Tree Value: 80%

Required Mitigation: 19.2 caliper inches

RECOMMENDATION: The tree is very large and healthy. A tree this size in a residential yard is fairly rare in Key West. There are no signs of decay or infestation based on my inspection. The applicant said they've had to replace the concrete of their pool due to the tree.


