A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, ACCEPTING A PUBLIC ART DONATION FROM JOHN PADGET OF AN ORIGINAL METAL AND WOOD SCULPTURE BY DAMON HAMM AND JEFF SUNDHEIM TITLED "WAVEHENGE," TO BE INSTALLED AT A LOCATION TO BE DETERMINED AT THE TRUMAN WATERFRONT PARK; AUTHORIZING AN EXPENDITURE NOT TO EXCEED \$12,000.00 FROM ART IN PUBLIC PLACES FUNDS FOR INSTALLATION OF THE SCULPTURE (CONCRETE PAD); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Art in Public Places Board unanimously recommends acceptance of Wavehenge donated art for placement at the Truman Waterfront Park, in a location to be determined, as illustrated in the attached diagrams; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby accepts the generous public art donation from John Padget of an original metal and wood sculpture by Damon Hamm and Jeff Sundheim, titled "Wavehenge," and authorizes installation of the artwork in a location to be determined at Truman Waterfront Park.

Section 2: That the expenditure of up to \$12,000.00 from Art in Public Places funds is authorized to be used for construction of a concrete pad as per the engineering drawings.

The transportation and installation of the art work by R.V.W. Sculpture will be paid by donor, Mr. John Padget.

Section 3: A building permit application may be required to be submitted and approved by City staff prior to installation.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
