**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING THE ATTACHED INTERLOCAL AGREEMENT BETWEEN THE MONROE COUNTY SHERIFF'S OFFICE (MCSO) AND THE CITY OF KEY WEST DEPARTMENT OF TRANSPORTATION, FOR SHARED USE OF THE 800 MHz P25 RADIO SYSTEM FOR A FOUR-YEAR TERM BEGINNING OCTOBER 1, 2025 THROUGH SEPTEMBER 30, 2029; PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the Transit Department of the City of Key West, Florida participates at a County level with hurricane and other emergency related evacuation, both in and outside of the County; and

WHEREAS, it was deemed appropriate for the City of Key West Department of Transportation to enter into an Interlocal Agreement with the Monroe County Sheriff's Office to share the use of their County-wide radio system; and

WHEREAS, the current Interlocal Agreement between the Monroe County Sheriff's Office and the City of Key West Department of Transportation for the shared use of the 800 MHz P25 Radio System will expire September 30, 2025; and

WHEREAS, the attached Interlocal Agreement between the Monroe County Sheriff's Office and the City of Key West Department of Transportation provides shared use of a 800 MHz P25 Radio System for a four (4) year term beginning October 1, 2025 and expiring September 29, 2029; and

WHEREAS, under this Interlocal Agreement, the City of Key West Department of Transportation will pay maintenance costs at the rate of \$285.25 per unit for FY 2025/2026 totaling \$7,987.00 to be paid in split percentages from the following Accounts as shown below; and

- 4114402-544.4100 (45%)
- 4114405-544.4100 (35%)
- 4114407-544.4100 (20%)

WHEREAS, the annual cost of maintenance will be reviewed each year and may be adjusted for each following fiscal year. The maintenance costs will be shared on a pro-rata basis based on the number of radios the City of Key West Transit Department and Shared Users are authorized to use on the System as of April 1<sup>st</sup> of each year;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby approves the attached four-year Interlocal Agreement between the City of Key West Department of Transportation and the Monroe County Sheriff's Office for shared use of a 800 MHz P25 Radio System to be funded in split percentages from Accounts 4114402-544.4100 (45%), 4114405-544.4100 (35%) and 4114407-544.4100 (20%).

Section 2. That the City Manager is hereby directed to execute the attached Interlocal Agreement and other necessary documents to include budget transfers/adjustments, upon consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
