A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES OF THE CITY OF KEY WEST, FLORIDA APPROVING THE PURCHASE OF ONE (1) 2029 PIERCE IMPEL PUMPER APPARATUS, INCLUDING ALL NECESSARY OPTIONS AND EQUIPMENT, FROM TEN-8 FIRE & SAFETY, LLC IN THE AMOUNT of \$1,035,994.49 (WITH OPTIONAL PRE-PAYMENT DISCOUNT) UTILIZING THE FLORIDA SHERIFF'S ASSOCIATION GOVERNMENT CONTRACT NO.FSA25-VEF19.0, FIRE RESCUE VEHICLES AND EQUIPMENT.; AUTHORIZING THE CITY MANAGER TO NECESSARY RELATED DOCUMENTS, EXECUTE ANY BUDGET TRANSFERS AND/OR ADJUSTMENTS, CONSENT OF THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 2-797(3) of the City's Code of Ordinances, Fire Department administrative staff have recommended the purchase of a fire pumper apparatus from Ten-8 Fire & Safety, LLC utilizing the Florida Sheriff's Association (FSA) Contract No. FSA25-VEF 19.0, Fire Rescue Vehicles and Other Equipment; and

WHEREAS, the Key West Fire Department (KWFD) budgeted \$1,100,000 this fiscal year (FY25/26) to purchase one (1) new pumper apparatus to replace Engine No. 5, our current reserve 2010 Pierce pumper. To meet the specific needs of the Fire Department, the quoted cost of these vehicles includes necessary options and emergency equipment to provide the KWFD with a custom-built chassis with many features, including Pierce's PUC configuration that eliminates the pumphouse, creating a smaller wheelbase and significantly reduced turning radius to enable our response through our island's narrow streets and alleys; and

WHEREAS, purchase of this 2029 Pierce Impel Pumper Apparatus from Ten-8 Fire & Safety, LLC, which includes all necessary options and equipment, will provide a modern, reliable fire apparatus in continuance of our goal toward a standardized fleet to quickly and safely respond to emergency calls for service and realign our Department in accordance with the goals outlined in the fleet replacement schedule of our strategic plan based on National Fire Protection Agency recommendations for fire apparatus; and

WHEREAS, rising costs for production and the limited availability of supplies and materials are expected to continue and any delay in replacing Engine 5 will likely increase apparatus repair and maintenance costs and future replacement costs; and

WHEREAS, the Florida Sheriffs Association Cooperative Purchasing Program (FSA) followed the attached Contract Terms and Conditions to procure this contract for fire apparatus. The FSA contract offers extended and guaranteed prices to any local government or political subdivision of the state, public educational institutions, other public agencies or authorities with the State of Florida, and other entities approved by the manufacturer participate in these contracts. Utilizing these awarded contracts provides a price level that the City could not achieve by purchasing this apparatus and equipment independently; and

WHEREAS, staff has determined the Pierce fire apparatus purchase offered by Ten-8 Fire & Safety, LLC is fair and reasonable in terms of pricing and the thirty-six(36) month delivery estimate. While Pierce is not the least expensive fire apparatus builder, they are not the most expensive, and represent a good balance of proven quality and price;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a purchase from Ten-8 Fire & Safety, LLC in an amount of \$1,035,994.49 (including optional pre-pay discount), of one 2029 Pierce Impel Pumper Apparatus with necessary options and equipment, is hereby approved, pursuant to Section 2-797(3) of the code of ordinances.

Section 2: That funds in the amount of \$1,100,000.00 are budgeted for this acquisition and allocated in FY 25/26 Fire Department Infrastructure Fund under Budget account 101-2201-522-6400. Necessary budget transfers and adjustments from Infrastructure Surtax Fund reserves account 101-2201-522-9803, are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute necessary documents related to this purchase upon advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
