A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER FROM AVIROM & ASSOCIATES, INC. IN THE AMOUNT OF \$72,775.00 FOR PROFESSIONAL SURVEYING SERVICES FOR THE VON PHISTER STREET SAFETY IMPROVEMENTS PROJECT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR AMENDMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE ANY NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 23-121, the City Commission approved a contract with Avirom & Associates, Inc. for General Surveying Services; and

WHEREAS, in Resolution No. 25-272, the City Commission approved a State Funded Grant Agreement (SFGA) for construction funding for "KEY WEST - VON PHISTER STREET SAFETY IMPROVEMENTS" (CSFA 55.039, Fund EM26, FPN: 456901-1-54-01)

WHEREAS, the task order for topographical route survey is essential for roadway design required to construct Von Phister Street Safety Improvements in support of the grant agreement and the Key West Strategic Plan goal of improving roadway infrastructure.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That a Task Order for Von Phister Street
Topographical Route Survey (#11406) is hereby approved in an
amount not to exceed \$72,775.00.

Section 2: This Task Order will be paid from account
102-4102-541-6300 (Internal Improvements / Infrastructure).
The Task Order supports "KEY WEST - VON PHISTER STREET SAFETY
IMPROVEMENTS" SFGA project (CSFA 55.039, Fund EM26, FPN:
456901-1-54-01) but is not a grant-eligible cost. Any
necessary budget transfers or adjustments are hereby
authorized.

Section 3: That the City Manager or designee is
authorized to execute any necessary documents, upon the
advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect
immediately upon its passage and adoption and authentication
by the signature of the Presiding Officer and the Clerk of
the Commission.
