Additional wayfinding and directional signage have been identified as opportunities for increasing the success of Mallory Square by the general public, the Sasaki design team and city staff.


402 Wall Street, the longtime offices of the Key West Chamber of Commerce, are in need of repair. The building has been vacant for five years. Hayes Robertson Group Inc, has proposed repairing the exterior limestone, removing the interior drop ceilings and exposing the beams, refinishing the terrazzo flooring, repairing the plumbing, moving HVAC equipment and upgrading the electrical fixtures.

Hayes Robertson Group further proposed improvements at this critical entrance to the Waterfront Mallory Square, including signage and an entry arch.

Hayes Robertson Group further offered, after repairing the City's building to rent it for \$91,368 per year potentially increasing by further offering 12.5% of sales. This is a percentage rent level higher than any other City lease.

Hayes Robertson Group is planning on selling Key West made products out of this location, and adding retail along the entrance to the square further driving traffic towards the water.

This is an opportunity that the City should take. Hayes Robertson Group Inc is qualified. Hayes Robertson Group made the only responsive bid to the City's Requests for Proposals 25-006.


