A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING THE ATTACHED "CUSTOMIZED TRAINING AGREEMENT" BETWEEN CAREER SOURCE SOUTH FLORIDA AND THE CITY OF KEY WEST, IN A TOTAL GRANT AWARD AMOUNT OF \$28,000.00 FOR PARTIAL FUNDING OF POLICE ACADEMY BASIC LAW ENFORCEMENT TUITION; AUTHORIZING A NECESSARY BUDGET AMENDMENT TO ACCEPT THE FUNDING TO OFFSET EXPENSES FOR POLICE ACADEMY TUITION OF APPROXIMATELY \$54,885.00, WITH THE DIFFERENCE (APPROXIMATELY \$26,885.00) TO BE FUNDED BY THE CITY MANAGER CONTINGENCY FUND; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Key West Police Department has a continuous need for Police Officers, and graduates from a locally sponsored Police Officer training program are a vital part of the KWPD's ability to provide public safety services to the community; and

WHEREAS, funding from Career Source South Florida will partially fund police academy tuition, and help to reduce the City's tuition costs.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Customized Training Agreement" between Career Source South Florida and the City of Key West for partial funding for Police Academy Basic Law Enforcement Tuition is hereby ratified in the total amount of \$28,000.00.

Section 2: That necessary budget amendments are authorized to accept the Career Source funding in account 001-0000-331-2000 (General Fund/Revenue/Public Safety) to partially offset the cost of police academy tuition, along with a budget transfer of approximately \$26,885.00 from the City Manager Contingency Fund account 001-1900-519-9801, to fund the tuition balance of approximately \$54,885.00, which will be paid from account 001-2101-521-5500 (General Fund/Police Department/Training) in FY 19.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
